[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Tennessee County of Roane: SS

Be it known, that in this the first day of January A.D. 1853 before me the subscriber an acting Justice of the Peace in and for the County and State aforesaid, personally appeared Mrs. Esther Varner a resident of said County, aged seventy-three years past, and made oath in due form of law, that she is the only surviving child of Mary Knox, who was an applicant for a Revolutionary Pension as surviving widow of affiant's father Robert Knox. 1 That her father Robert Knox, aforesaid, served in the War of the American Revolution in the State of North Carolina, and was living, at the time of his services in the County of Pitt; Affiant's father, said Robert Knox served three years and six months, most of the time in the capacity of Lieutenant, and affiant has often seen his commission, but for the disposal of all of his papers, affiant refers to proof upon file in the Pension Office. Affiant further declares that her father, said Robert Knox and mother said Mary Knox, (whose maiden name was Crandell), were married in the County of Pitt and State of North Carolina, and prior to the last actual service of said Robert Knox, affiant's father. Affiant makes this declaration in order to obtain that benefit of the act of Congress of July the 4th 1836, but hopes to establish her claim, by the act of Congress, approved May the 7th 1846, and the proof already upon file in the Pension Office, that which accompanies this declaration, and that which her agent may hereafter file.
