Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I certify that I have examined the claim of the Heirs of the late Thomas Landrum, deceased who was a Surgeon's Mate in the Navy of the State of Virginia during the revolutionary war: that he continued in the service until the reduction of the Navy in 1781, when he became supernumerary; that he died in 1811; that the case is embraced by the provisions of the act of the July 5th 1832, entitled, "an act to provide for liquidating and paying certain claims of the State of Virginia;" that the claim should therefore be allowed at the rate of \$91.25 since per annum from the 22nd of April 1783, when the war terminated, to the 10th of January 1811 the day on which his last will and testament is dated and that the amount is payable to the Honorable John Taliaferro, M. C. who is fully authorized by Thomas Green of Richmond Virginia attorney of Elizabeth W Collins, administratrix of Thomas Landrum deceased to receive the sum due. Approved

I certify that I have examined the claim of the Heirs of Thomas Landrum deceased who was a Surgeon's Mate in the Virginia State Navy and it appears that they were, in May 1838, allowed half pay under the act of July 5th, 1832, entitled "an act to provide for liquidating and paying certain claims of the State of Virginia" from the 22nd of April 1783 to the time of his death in January 1811. The Heirs of now as for half pay under said act from the time when the Navy was reduced and when he left the service, up to the 22nd of April 1783, and I find that the same is due. I therefore certify that they are entitled to half pay from November 30, 1781, when he left the service, till 22nd of April 1783, at the rate of \$91.25 per annum: and that the amount is payable to Henry Northup, attorney of Elizabeth W Collins of Westmoreland County, Virginia, administratrix of Thomas Landrum deceased.

Heirs of Thomas Landrum - Surgeon's Mate Navy

The facts are – an allowance of land has been made to Thomas Landrum as a soldier of the Continental line –an individual of the same name was Surgeon's mate on board the *Tempest* in September, October, November & December 1779 – Regular pay rolls of the officers then of the *Tempest* down to a later [?] period have not been preserved. The Journals of the Navy Board do not show that he left the service. The strong presumption is he remained in service until the reduction of the Officers of the Navy the last of 1781: and was then supernumerary, or he might have remained in service to the end of the war. In addition a witness proves a service of 3 years as Surgeon's Mate.

I think he should be allowed land, for a service of three years: & if he was the same person who received land as a soldier, the quantity allowed in that character should be deducted. This claim has been [indecipherable word] upon List No. Two.

At Request I certify that I was on board of the Ship *Tempest* (commanded by Captain Celly Saunders of the Virginia State Navy in the War of the Revolution) upwards of three years, having enlisted for that length of time and Surgeon's Mate Landrum was on board the said ship the same length of time. I knew him well and can therefore speak with a degree of certainty.
