Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Caswell County

Elizabeth McAden on this the 23rd day of January 1855 personally appeared before me Richard J. Smith an acting Justice of the peace within and for the County and State aforesaid Elizabeth McAden Aged 78 years who being duly sworn according to law declares that she is the widow of John McAden deceased who was a private Soldier in the North Carolina Regiment commanded by General Greene [Nathanael Greene] in the Revolutionary that her said husband enlisted at Martinsville Guilford County North Carolina on or about the 1st of day of February 1781 for the term of six months and continued in actual service for the time of six months and was honorably discharged at on the day of as will appear by the muster rolls; She further states that she was married to the said John McAden in Caswell County on the 30th day of November 1798 by one William Moore (Clergyman).

That her name before her said marriage was Elizabeth Murphy that her said husband died at home on the 7th of October 1845 and that she is still a widow. She makes this declaration for the purpose of obtaining the pension due her husband for revolutionary Service under the act passed May the 18th 1828 and due him under the act passed the 7th day of June 1832: and due her under the act passed the 7th day of July 1838, and the Supplementary acts thereunto passed the 2nd day of February 1848. No discharge to be found.
