[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of North Carolina Union County: Court of Pleas and Quarter Sessions October term 1853 On this 4th day of October A.D. 1853 personally appeared in open court Before the Court of Pleas and Quarter Sessions in and for the County of Union and State aforesaid Hugh B. McCain, a resident of said County and State aged Sixty-four years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the acts of Congress passed July 4th 1836 and July 7th 1838 and all other acts applicable to his case That he is the son of Hugh McCain who was a soldier of the Revolutionary War and served in the Army of the United States under Captains Davis [Robert Davis] and John Foster in the southern division of the Army commanded by Generals Sumter [Thomas Sumter] and Irwin [Robert Irwin] the precise length of time he does not know But to the best of his recollection is Father's Service between 9 and 18 months that he was in the Battle at the hanging Rock [August 6, 1780] and several skirmishes with the Tories that he has no means of proving his Father's Service by any living witness the old soldiers of the revolution being nearly all dead that his Father Hugh McCain was a resident of Mecklenburg County when he entered the Army and acted as orderly Sergeant and after the term of service he returned to Mecklenburg County and was married to Isabel Baskins January 23, 1787 as will more fully appear from the annexed leave taken from the old family Bible and that he died on the 6th day of March 1832 and his wife Isabella died on 18 July 1842, as will appear from the proof hereunto annexed. 



William Polk's] Regiment in Sumpter's [Thomas Sumter's] Brigade of State Troops this our INDENTED CERTIFICATE for the Sum of Ninety four pounds Sterling<sup>3</sup> being amount pay and bounty due him for Services in that Troop Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last."]

<sup>&</sup>lt;sup>3</sup> Men who enlisted for ten months in April 1781 in the SC State Troops of Light Dragoons under Sumter were promised wages payable in slaves taken from the Tories. Such 'pay' was known as "Sumter's Wages." When that horrific form of payment could not be made because too few slaves were confiscated from the Tories, the SC Legislature authorized the payment in pounds Sterling deemed to equal the value of the slaves not delivered (to wit, £94 Sterling for one 'grown Negro').
