[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This day James H McCall personally appeared before us Casper Hargett and George W Houston two of the acting Justices in and for said County and after being duly sworn saith that he is 69 years old and that he is a son of Elizabeth McCall the above affiant and has remained in the family ever since and kept the family record and says his father died December 5th, 1827 he also says he has often heard his father and mother say he was Drafted three three months towers [tours] and served two tours and from the circumstance of his family he hired a substitute which he paid out of his own pocket for the third touer [sic].

On this 28th day of November A.D. 1851 personally appeared before the undersigned Clerk of the Circuit Court in and for said County (and duly authorized by the laws of this State to administer oaths, take the knowledge of the &c) William Stewart a resident of said County and State aged 88 years, who being by me first duly sworn according to law, on his oath saith that he was personally acquainted with William McCall during the war of the Revolution, that he believes he was drafted to serve a tour of duty of 6 or 9 months, and that he hired a substitute by the name of Richard Trimble, that he does not recollect what company what Regiment it was in. That afterwards this deponent knows that the said William McCall served in a company commanded by Capt. Matthew Stewart until the said Capt. Resigned in consequence of old age and inability and was then commanded by Capt. Thomas Shelby his successor the company was under the Control of General Davidson, that Deponent served in the same Company with said William McCall -- and after the above service the said William McCall was again drafted or he volunteered, about the time Lord Cornwallis was in pursuit of General Morgan through the State of North Carolina and served a tour of duty, but deponent does not recollect who commanded the Company. Deponent further states that first service was in the year 1778 or 9 the 2nd service was in the year 1780 and the 3rd service was in the year 1781 and it is his impression that said William McCall returned in the march or April following the two last named service was performed on horseback.

Clerk of the Circuit Court in and for said County (and duly authorized by the Laws of this State to administer oaths, take acknowledgment of Deeds &c) William Stewart a resident of said County and State, aged Eighty Eight years, who being by me first duly sworn according to law, on his oath says that he was personally acquainted with William McCall during the war of the Revolution, that he believes he was drafted to serve a tour of duty of Six or 9 months, and that he hired a substitute by the name of Richard Trimble, that he does not recollect what Company, or what Regiment it was in. That afterwards, this Deponent knows that the said William McCall served in a Company commanded by Captain Matthew Stewart until the said Captain Resigned in consequence of old age and inability, and was then commanded by Captain Thomas Shelby his successor the Company was under the control of General Davidson [William Lee Davidson], that Deponent served in the same Company with the said William McCall – And after the above service the said William McCall was again drafted or he volunteered, about the time Lord Cornwallis was in pursuit of General Morgan [Daniel Morgan] through the State of North Carolina and served a tour of duty, but deponent does not recollect who commanded the Company, Deponent further states that 1st service was in the year 1778 or 9, the 2nd service was in the year 1780 and the 3rd service was in the year 1781 and it is his impression that said William McCall returned in the March or April following. The 2 last named service was performed on horseback

[p 44: On January 6, 1852 in Mecklenburg County North Carolina, James H McCall gave testimony that the record containing the names of the children of William and Elizabeth McCall was torn from the family Bible of Elizabeth McCall and that he, affiant knows the record to beach true and genuine; that the record was 1st capped in an old catechism of "Fishers" and was transcribed some time before his father's death in his own hand writing on the title page of the New Testament; that the names of the children of William and Elizabeth McCall found on said page are as follows: James H McCall, William McCall, Matthew McCall, Hugh McCall, Jane McCall, Thomas McCall, John McCall, Eli McCall, Joseph McCall, Azariah McCall.

State of Illinois White County

Before the undersigned Clerk of the Circuit Court, in and for said County, this day personally appeared William Stewart aged 89 who being by me first duly sworn according to law, on his oath deposes and says, that some time in the month of February in the year 1778 William McCall was married to Elizabeth Stewart, in the house of her father, Capt. Matthew Stewart, that the said marriage was solemnized by the Rev. Thomas McCall a Presbyterian

Clergyman, that the said marriage took place in Mecklenburg County in the State of North Carolina, that deponent was present and witnessed the solemnization thereof.

That deponent further states on oath that he was personally acquainted with said William McCall, and knows that he served three tours in the revolutionary war. The first tour he was drafted for the term of six or nine months deponent does not recollect which, that he, McCall, for said tour hired a substitute by the name of Richard Trimble deponent does not recollect whether McCall served personally any of this tour, but does know that he furnished a substitute. Deponent does not recollect the number of the Regiment or the name of the officers commanding it, but it was what was known as the Wilmington or Newberg [New Bern ?] expedition, that said McCall at that time resided in Mecklenburg County in North Carolina. The second Tour was under Capt. Matthew Stewart for a part of the time and until the said Capt. resigned, and then under Capt. Thomas Shelby as his successor, that he the said McCall volunteered in this tour sometime in the summer of 1780 that to the best of deponent's recollection this tour was for the term of six months that this company was under the control of General Davidson [William Lee Davidson]. The third tour he was drafted or volunteered about the time Lord Cornwallis was in pursuit of General Morgan [Daniel Morgan] through the State of North Carolina, that is to say about the month of January 1781, that he does not recollect the names of officers commanding, that the tour was one of great excitement, and hurry and every man that could go went and McCall returned home from this service, to his house in the County of Mecklenburg North Carolina sometime in the month of March or April 1781 that the two last services mentioned above were performed on horseback.

Deponent further states that he took papers belonging to the said McCall to the Auditors office, and delivered them to a man by the name of Wilson a commissioner to ascertain the amount due the soldiers for services in the war, and deponent thinks that it is more than probable that among those papers McCall's discharges was taken and that there may be still some account or information respecting said services found in said Auditors office of the State of North Carolina.
