[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia Columbia County:

On this the eighth day of January 1856, personally came before me Stephen Drane, a Judge of the Inferior Court, a court of Record for & in said County & State, Francis McGuire, Jr., who being first duly sworn, saith his father John McGuire was a private in the South Carolina Continental or militia service in the Revolution with Great Britain in 1776, and, he makes this Declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832. He further states that his Father, was in the battle at Kings Mountain in 178_ [October 7, 1780], and, also, at Sullivan's Island in 178_ [June 28, 1776], and, any others he does not remember and he further states that he is the only living child of the said John McGuire, who entered the war in Spartanburg District SC he thinks as he lived on Deep River during the war, and, he further says, all the papers of his father were in Kentucky with his Brother who is now dead, and, all the papers destroyed; hence, he has no records public or private, by which to prove his service, but, he thinks may have served under Merry McGuire, but he is not sure. And he further declares and says, that, his father John McGuire died in the month of January 18th day, in the year 1848, that, he has no record of it.

And he hereby relinquishes all claim whatever, to any pension or annuity except the present, & if his name was ever on the Pension Roll of any State, he is not aware of it. Sworn to & subscribed this the day & year above written.
