Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." John Mitchel of Lewis County aged 71 yrs has known Robert Means for the last 22 years. and in that time had frequent conversations with him, about the Struggle for Independence. In one of which conversations. he recollects distinctly. that Means Said that he had come to the United States (from Ireland) after the close of the Revolutionary War.

Samuel Bennett has heard Means say more than once that he was not in the Revolutionary War. at that time he was on the other side of the ocean.

William Powers aged 71 has had frequent conversations with Means. believes that he was not a Soldier in the Rev. War.
