Pension application of Charles Merrill (Merrell) R7126 Elizabeth Merrill f9NC Transcribed by Will Graves 4/28/09: rev'd 4/7/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Alabama Marshall County

On this 25th day of September 1843 personally appeared before the Subscriber an acting Justice of the peace in and for the County & State aforesaid Elizabeth Merrill wife & relict of Charles Merrill deceased who first being duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Acts of Congress passed 7th of July 1838 and the 23rd of August 1842 granting pensions to widows of persons who served during the Revolutionary War. That she is the widow of Charles Merrill who was a soldier of the Revolutionary War but how long he served she is not now able to declare. She only knows of one person in this country who was known to the Service of her Husband (viz.) Peter Headrick, & he lives 200 miles off from her residence. She also declares that she was married to the said Charles Merrill on the 23rd day of May 1783. That her husband the aforesaid Charles Merrill died on or about the 14th 1822 [sic, no month stated]. That she was not married to him prior to his leaving the Service but the marriage took place previous to the first of January 1794) viz.) at the time above stated. She further declares that she is still a widow. She hereby relinquishes every claim whatever to a pension or annuity except the present & that her name is not on any pension roll of the agency of any State in the Union.

In addition to the above She also declares that she is totally unable from age & infirmity of attending a Court of Record as is required if able.

[John Cunningham of Cherokee County Alabama gave an affidavit stating that he was acquainted with Charles Merrill and his wife Elizabeth Merrill in the state of North Carolina in Roan [sic, Rowan] County; that Charles Merrill had the reputation of being a revolutionary war soldier in the neighborhood in which he lived; that Charles and Elizabeth world lawfully married. He also states: "I also further declare that Charles Merrill was a son of Benjamin Merrill who was hung by the British at Hillsboro North Carolina."]
