Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

The state of Kentucky Madison County Sct.

On this 24<sup>th</sup> day of May 1853 personally appeared before me, a Justice of the Peace in and for the County & State above written, Robert Miller, in the 79<sup>th</sup> year of his age, who first being duly sworn according to law doth upon his oath state that he is the Eldest son of Captain John Miller deceased who was a soldier in the War of the Revolution. He further states that his father the said Captain John Miller was a Captain in the militia service of Virginia, that he volunteered in Albemarle County in the State of Virginia, and raised a company, that he served under Major Boyce and Colonel Reuben Lindsay. He further states he cannot give the Precise date when he first volunteered, but thinks it must have been near the close of the war 1780 or the first of the following year, that he served three tours of three months each, that he was in the service at the time Tarlton [Banastre Tarleton] came to Charlottesville Virginia, and was also at the siege of York. He further states that he supposed his father the said John Miller deceased was discharged about the time Lord Cornwallis was taken [October 19, 1781]; but that his discharges have been lost. He further states that his father the said Captain John Miller was married on the 28<sup>th</sup> day of March 1774 as will appear from the family record, while he lived in Albemarle County, to his wife Jane Miller, whose name before marriage was Jane Delaney, and who was residing at the time of her marriage in Orange County in the State of Virginia, in that part which is now called Madison County. He further states that his father, the said Captain John Miller died September 8<sup>th</sup> 1808 and his wife the said Jane Miller lived until March 13<sup>th</sup> 1844 leaving only himself, Joseph Miller and Jane Lackey [could be Luckey or Suckey] the only living children & having never married again but remaining the widow of the said Captain John Miller deceased. He makes this declaration for the purpose of obtaining the benefit of the Act of Congress of the United States passed and approved the 4<sup>th</sup> July 1836, or any other act or acts by which he may be entitled.

State of Kentucky Madison County

The affidavit of Thomas Maupin<sup>1</sup> to be read as evidence upon the Claim of the Heirs and Children of John Miller who was a Captain, in the 19<sup>th</sup> Regiment of the Virginia Militia, being of lawful age and first sworn – Affiant states that he was born in the County of Albemarle and State of Virginia, and was born in March 1765 – and removed to Madison County Kentucky sometime in the year 1800, and has been residing in Madison County since that time. Affiant states that he was raised in the same County with John Miller, who resided in Albemarle County Virginia and knew him when I was quite young. This is the only John Miller I in Virginia or in Kentucky that served in the above service of the Virginia militia, I served with him as Captain, – and was a soldier in his company. I served under him six months – I served nine months in all but served a tour of three months under a different Captain. I served the first three months, and also the last three months under John Miller. Our March was below Richmond Virginia, and also in the direction of Williamsburg Virginia. I was discharged a short time before Captain John Miller being an officer. He was retained in the service longer than the Soldiers. We were all discharged a short time before the surrender of Cornwallis at Yorktown [October 19, 1781]. I was always intimate with John Miller and knew him well, both in Virginia & Kentucky, he moved to Madison County Kentucky some years before I did, I knew him all these times, but to his death and he died in Madison County Kentucky. Captain John Miller was married in Albemarle County Virginia to one Miss Jane Delaney. When he left Virginia I do not recollect how many children he had, but at his death, he left a large family of grandchildren, I am confident he never drew a pension, and never heard of his applying for one – his widow Jane Miller died some years

ago in Madison County and subsequent to the deaths of John Miller – I do not know any of the soldiers that were in the company that are now living. I had a brother with [ink blot obliterates one or more words] other company of Captain John Miller. The name of our Colonel was Colonel Reuben Lindsay. I think our Major was by the name boy aid or boy aged. If Captain John Miller did not received his discharge I do not know why he did but, as he did serve when I was with him as faithfully as any officer – he was universally regarded, before he left Virginia, and after he removed to Kentucky as a Revolutionary Officer – And twenty years ago the same facts could have been proven, or his time, and the Term of service as an Officer of the Revolutionary War in Madison County by a dozen witnesses; who resided in Madison County. I am a revolutionary Pensioner and reside in Madison County Kentucky.
