Pension application of Andrew Millican R7235 Transcribed by Will Graves Lettice Millican f18NC 5/3/09: rev'd 4/19/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia County of Madison

On this third day of June 1853 personally appeared before me Martin Deadwyler, JIC a Justice of the Inferior Court for the County and State aforesaid Lettice Millican a resident of Madison County in the State of Georgia aged ninety-one years who being first duly sworn according to law, doth, on her oath, make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed the 4th day of July 1836: That she is the widow of Andrew Millican who was a private soldier, and Lieut. in the militia of North Carolina during the revolutionary war. That he resided in Rutherford County entered the service about the time of what was called the Snow Campaign in 1776 or 1777, and she thinks under Col. Hampton and Major Alexander and from that period on till a short time before, or about, the battle of Kings Mountain [October 7, 1780] he was then numerous Tours of service but under what officers she is unable to state positively -- from her best recollection of what she recollects to have heard her husband and others say he served under, or in connection with, the command of captains Cowan [perhaps Thomas Cowan of Rowan County], Bell [perhaps Captain William] Bell of Rowan County], Simmons [perhaps Captain Richard Simmons], Wood [perhaps Captain Samuel Woods of Burke County] and Shipman [perhaps Captain Daniel Shipman] -- Colonels Lock [Francis Locke?], Thaxton [James Thackston?], Majors Maberry & Gray, and Generals Davidson [William Lee Davidson] and Rutherford [Griffith Rutherford]. --

She further declares that she was married to the said Andrew Millican on the __day of January or February 1778. That she has no record of the date of her marriage, which took place in Rutherford County North Carolina, That the enclosed paper contains the record of the births of her first and second children, that said record of births is original, genuine and in the hand writing of her husband the said Andrew Millican, and that her name before marriage was Lettice Clayhorn. That her husband the aforesaid Andrew Millican died on the 29th day of January 1830, and that she has remained a widow ever since that period as will more fully appear by reference to the proof hereto annexed. She further swears that she was married to the said Andrew Millican prior to his last Tours of service in the Army.
