Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Indiana Union County: The deposition of Jesse Pigman<sup>1</sup> aged Seventy-two years taken before me George Newland a Justice of the Peace in and for said County and State on the 4<sup>th</sup> day of October 1836. The deponent being first sworn deposeth and saith that Amos Milner was a soldier in the revolutionary war and that the said Milner served about four years in the said Army as a private Soldier under Captains Jesse Pigman and Joseph Vanmetre in the Monongahela Country in what was called the Virginia line under Colonel John Miner and the deponent also states that said Amos Milner was a Soldier in the Indian war under Captain Ellis in General St. Clair's Army and served about 8 weeks and further saith not. Also at the same time and place the depositions of Samuel Foster<sup>2</sup> aged seventy-four years and Job Preble<sup>3</sup> aged Seventy Six years, the deponents being first sworn saith that the above named Amos Milner served as a private Soldier four years in the Revolutionary war under Captains Jesse Pigman and Joseph Vanmetre under Colonel John Miner in the Monongahela Country in what was then called the Virginia line and that the said Amos Milner was a Soldier in the Indian war under Captain Ellis in General St. Clair's Army and served about Eight weeks and further they say not.
