Pension application of Shepherd Mize R7287 Transcribed by Will Graves f14VA 6/21/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Georgia County of Newton: SS

On this 25th day of December 1832 personally appeared in open court before the Judges of the Inferior Court now sitting Shepherd Mize a resident of Newton County and State of Georgia aged seventy-one years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated. General Stephens [Edward Stevens] commanded the Brigade & Colonel John Glenn commanded the Regiment & William Collier commanded the Company that he entered the service sometime in the month of September 1780 and that he left the same sometime in the month of January 1781 serving a tour of four months that at the time he entered the service he resided in Lunenburg County in the State of Virginia that he served said tour as a drafted militia man. That he enlisted in the service of the United States on the 12th day of January 1781 under Colonel Henry Lee [Henry "Light Horse Harry" Lee] for three years or during the War and served until the 18th day of February 1781: when he received a permit from Colonel Lee to return home and remained until fit for service or called by Colonel Lee having been taken sick on the 18th of February 1781: that the said permit was prolonged by a regular officer that he remained sick and unfit for service during the war. That he was in the battle at Georgetown. That he marched through the States of North Carolina and South Carolina. That he served with Colonel Lee Continental Regiment. That he knew General Green [presumably Nathanael Greene], General Marion [Francis Marion] & Colonel Horry Continental officers. That he has no documentary evidence and that he knows of no person whose testimony he can procure who can testify to his service.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the Agency of any State.

Sir, in answer to your letter I will state in relation to my father's Revolutionary Services that he

served a 6 months tower [tour] towards the close of that war he died in the State of Georgia DeKalb County he left no widow he was married in the State of Virginia Lunenburg County my mother died in South Carolina Union District in 1802 I don't recollect any officer at the present but Colonel Lee as his discharge was destroyed by the burning of the house but is possible more can be come at he died in the year 1836 in DeKalb County Georgia.
