Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Georgia County of Whitfield}

On this 18th day of February 1854, Before me the Undersigned one of the Justices of the Inferior Court in and for the County and State aforesaid, Personally appeared Wiley D. Morgan aged 60 years a Resident of the County of Whitfield in the State of Georgia, who being cautioned and then sworn in due form of law, declares on oath that he is the Son and Heir of Orman Morgan who was a Revolutionary Soldier of the State of North Carolina and who is now dead, that he died on or about the 12th day of November A.D. 1829. And that his Mother named Polly Morgan died on or about the 30th day of April A.D. 1828. And that they were married in the State of North Carolina on or about the 1st day of September A.D. 1779. Deponent further states that he has heard his Father say that he served 6 years in said War as a Continental Soldier and continued in actual Service until the close of the Revolutionary War: and deponent further declares that he has seen his Father's certificate of discharge, but that the same was destroyed by fire and that he never received any pension money nor made any previous application therefore.
