

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



"Augusta Nov. 27th 1777

Philip Morgan a Previt Solder in Capt. Isaac Hicks Company in the 3d Battalion of Contintal Troops for the State of Georgia, being in Bad State of Health and not fitt for Duty is Discharged from the Said Battalion, he having Received all pay and Arears of pay to this Day



The Declaration of Jesse Peter acting Executor of Philip Morgan deceased for the benefit of the heirs of said Philip Morgan Washington County State of Kentucky being of lawful age and sworn in the County court Washington, makes the following Statement that he the said Peter is at this time the acting Executor he was well acquainted with Philip Morgan & his wife Patsey for upwards of 25 years and that during that time they lived comfortably Together as man & wife I have no recollection of their marriage they Departed this life Philip Morgan September 28th 1826, his wife Patsey Departed this Life the 24th day of July 1837 and that she remained a widow until her death. I have found in his possession two discharges which will be forwarded to the Commissioner of Pensions. I have no knowledge of his services or Enlistment. I no [know] he possessed in the year 1815 upwards of \$1500 in property two tracts of land one 210 acres and one other 185 [acres] that I suppose one reason why he made no application for his Pension that he was a very particular man with respect to fraud or any illegal practices to obtain unjust claims. I have also produced the family record of the Bible in court for their examination as a precise [?] Copy for the Department of War's inspection there was nine children two dead & seven living the deaths ages will appear on the family Record all over sixteen years of age no Guardian the court will certify the character of Jesse Peter he further states that the law requires a valuation of property & pension Depended on the amount of property [attested by W. B. Booker, Clerk]
