[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Mississippi, Copiah County

This day personally appeared before the undersigned Associate Justice of the County Court of Copiah County Clement Mullins a resident of the State and County aforesaid aged about 82 years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832.

That he volunteered about the year of 1775 or 1776 in the state of North Carolina under Captain Goodloe [Richard Goodloe] and belonged to Colonel N. Long's [Nicholas Long's] Regiment was at that time a citizen of Franklin County North Carolina and was marched to Norfolk about the time it was burnt. I was marched back to Franklin County and discharged was in service in this tour in all five weeks. Sometime after I was drafted in the militia and hired a Substitute but do not recollect the officers' names the Substitute Served three months and returned home. Soon after one Wells Miliner was drafted and hired me to take his place I then served three months and 10 days I was marched to the Charwraw [sic, Cheraw] old fields on Pedee River under Captain Richards [James Richards] who belonged to Colonel Sowell's [Benjamin Seawell's] Regiment under General Sumner [Jethro Sumner] I was marched to Salisbury and then discharged, that he has no documentary evidence and that he knows of no person whose testimony he can procure who can testify to his service. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares his name is not on the pension roll of the agency of any State. Question first where and in what year were you born. I was born in North Carolina about 1750 Question 2nd have you any record of your age and if so where is it. I have no record of my age. Question 3 where were you living when called into service where have you lived since the revolution war and where do you now live. I was living in North Carolina during the revolutionary war about 1783 I moved to Georgia and now am living in the State of Mississippi. Question 4th how were you called into service were you drafted did you volunteer or were you a substitute and if a substitute for whom. I first volunteered and served five weeks I then was drafted and

^{3&}lt;sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

^{4&}lt;sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if a substitute, for whom?

^{5&}lt;sup>th</sup> State the names of some of the regular officers who were with the troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

^{6&}lt;sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it? 7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.]

hired a Substitute who served three months I then Substituted for one Wells Milner was marched to Pedee River and then to Salisbury where I was discharged I served three months and 10 days as a Substitute. Question 5 State the names of some of the regular officers who were with the troops where you served. I was with General Sumner a Militia General [sic, Sumner was an officer of the NC Continental Line] there was no regulars with me.
