Pension application of Benjamin Ogle R7778 Transcribed by Will Graves f23VA 12/16/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Illinois County of St. Clair: SS

On this 24<sup>th</sup> day of February 1840 personally appeared in open court, before the court of the Circuit court now sitting at Belleville for the County of St. Clair and State of Illinois Benjamin Ogle a resident of said County of St. Clair & State of Illinois aged 7? [last digit overwritten and illegible] who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832. That he entered the service of the United States on the following named officers and served as herein stated, that he entered the service (at a place called the "Court house Fort" in Ohio County in the State of Virginia) in the year 1781 in the latter part of said year as a militia man in a company commanded by Captain Joseph Ogle and Lieutenant John Biggs, which company was in a Regiment or Battalion commanded by Colonel Silas Hedge during this year the Fort was attacked and some of the company killed, he further states that he performed duty regularly as a militia man mounting guard and scouting with the other troops until the close of the war that during the year 1782 a part of the company with Lieutenant John beaks went on an expedition under Colonel Crawford [William Crawford] against the Indians where Biggs was killed. This declarant states that owing to his youth he was retained in the Fort where he done all the duty that failed to the part of any private of the company having been accustomed to arms at a very early age. That he has no written discharge or documentary evidence and that he knows of no person now living by whom he can prove his services. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state.

State of Illinois St. Clair County SS: This 22<sup>nd</sup> day of February 1840 personally appeared in open Court, the Court then Judicially sitting in and for the County of St. Clair & State of Illinois it being the Circuit Court of said County Benjamin Ogle who being duly sworn made the following answers to the following interrogatories

First Where and in what year were you born?

Answer. I was born in the County of Frederick State of Maryland in the year 1769 - Second Have you any record of your age; and if so where is it -

Answer – I have seen the record of my age in some book of my Father, in the State of Virginia, it is 30 years since I have seen the record – and it is now lost –

Third Where were you living when called into service, where have you lived since the Revolutionary war. And where do you now live?

Ans. When called into service which was in the year 1781 when I was but 12 years of age I lived in Ohio County State of Virginia. – In the state of Virginia and the State of Illinois – I lived with my children some part of the time in the County of St. Clair aforesaid and some part in the Territory of Illinois

Fourth. How were you called into service Were you drafted; did you volunteer, or were you a substitute; and if a Substitute for whom?

Ans. Answer I volunteered on my own account

Fifth. State the names of some of the regular officers who were with the troops where you served such Continental and militia regiments as you can recollect, and the general circumstances of your service –

Answer I entered the service in a company of militia commanded by Captain Joseph Ogle & Lieutenant John Biggs of Virginia – I recollect Colonel Silas Hedge whether he was a Continental or militia officer I cannot say; he was over the others – I do not recollect the number of any Regiment either Continental or militia – My service commenced at a place on the Ohio River above Wheeling called the "Court house Fort" since called West Liberty – I remained in service during the war – I removed in May 1785 to the Illinois and in 1788, in the Illinois I received a wound from a ball which penetrated my shoulder and lodged beneath the shoulder blade where it now remains.

Sixth Did you ever receive a discharge from the service; and if so by whom was it given and what has become of it

Ans. I have no knowledge of receiving a discharge other than being disbanded with the militia at the close of the war.

Ans. – Joseph Lemen and James Pulliam clergyman – live in my neighborhood and all well acquainted with me and can testify to my character for veracity & their belief of my services as a Soldier in the Revolution –
