[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia County of Stewart: SS

On this Eighteenth day of August 1837 personally appeared in open Court before us Daniel Mathieson, John S. Rice and Matthew Wright Justices of the Inferior Court in and for said County John Perkins a resident of the County of Stewart in said State aged Seventy Eight years on the nineteenth day of August last past, who being duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832. That he volunteered in the State Troops of Georgia as a volunteer Horseman in the month of July in the year 1778 under Colonel Elijah Clarke of Wilkes County Georgia and went in pursuit of Indians to the Cherokee purchase now the northern frontiers of this State: was in several skirmishes with the Indians, but no pitched battle. That he continued in the service as a horseman volunteer private until sometime in the month of October in the same year of entering, but he cannot now state positively from loss of memory the date of entering and exiting from the service in the month of July & October of the year mentioned he therefore makes the following affidavit: Personally appeared before me the undersigned a Justice of the peace in and for the County John Perkins who being duly sworn deposeth and saith that by reason of old age and the consequent loss of memory he cannot swear positively as to the precise length of his service, but according to the best of his recollection he served not less than the periods mentioned below and in the following grades for four months I served as a volunteer Horseman as a private and for such service I claim a pension.

The applicant further states that in the same year above stated he volunteered as a volunteer private footmen under Captain Greenbury Lee the Regiment being commanded by Colonel Benjamin Few, that he marched from Wrightsborough in Richmond now Columbia County Georgia to go to the County of Burke at the Court House: at which place he remained 2 or 3 weeks guarding the jail which was then occupied by Tory prisoners, at this place we had several skirmishes with the Tories who endeavored to release the prisoners in jail. I remained in service for one month under the aforesaid Captain when I returned home but cannot from old age and the

loss of memory now remember at what time I entered or when I left the same he therefore makes the following affidavit:

Personally appeared before me the undersigned a Justice of the peace in and for the said County John Perkins who being duly sworn deposeth and saith that by reason of old age & the consequent loss of memory he cannot swear positively as to the precise length of his service but according to the best of his recollection he served not less than the periods mentioned below and in the following grade for the month a volunteer private footmen for which I claim a pension. The applicant further states that he again entered into service as a volunteer private footmen in the year 1779 under Captain Samuel Beckom [sic, Samuel Beckham?] of the Georgia Troops and believes some time in the month of June of that year, that the Army rendezvoused at Captain Lee's from which place they started to Savannah. That he was at the Siege of Savannah of the same year, from whence he returned home. That he cannot state what day of the month he entered the service but recollects the corn was about waist high nor does he recollect when he left the service after the Siege of Savannah but remembers it was very warm -- Personally came before me the undersigned a justice of the peace of said County John Perkins who being duly sworn deposeth and saith that by reason of old age and loss of memory he cannot swear positively as to the precise length of his service but according to the best of his recollection he served not less than the periods mentioned below and in the following grade for 2 months and 15 days, I served as a volunteer private footmen for which I claim a pension. The applicant further states on oath that he again entered the service as a volunteer private footmen under Captain Josiah Drew of the Georgia Troops & commanded by Colonel Benjamin Few sometime in the year 1781. That he served nearly the whole of the year of 1781 and was at the Siege of Augusta that during the year 1781 he was in several skirmishes with the Indians & Tories but cannot now remember places time & dates nor does he remember at what time he entered the service or when he left it but recollects that he served nearly the whole of the year 1781 as a private under the officers mentioned.

Personally appeared before me the undersigned a Justice of the peace in & for said County John Perkins who being duly sworn deposeth & saith that by reason of old age and the consequent loss of memory he cannot swear positively as to the precise length of his service (for the year 1781) but according to the best of his knowledge recollection he served not less than the periods mentioned below and in the following grade for 10 months as a volunteer private footmen and for such service, I claim a pension

The applicant further states on oath that he again Entered in the service as a volunteer private footmen of the State of Georgia under Captain Samuel Alexander in the year 1782 some time in the month of Marched 1782 and volunteered for 6 months. That he left he marched from Augusta Georgia to Savannah, that he marched on to Ebenezer by way of Samons [?], Butler, Spirit & McBeans Creek to Briar Creek -- from Ebenezer to Savannah where I remained until after the siege, from thence he returned home which was some time in the month of August about as he now recollects about the last thereof. He believes the Siege of Savannah commenced about February of 1782 and lasted to about the 24th of August 1782 he further states that he entered the

service as a volunteer as last aforesaid in March and left in August of the year 1782 a period of 6 months for none of which several services did he ever receive a discharge, as they were not usually given.

He hereby relinquishes every claim whatever to a pension or an annuity except the present, and he declares that his name is not on the any pension Roll of any agency of any State. Sworn to and subscribed the day & year aforesaid.

Personally came before the undersigned a Justices of the Inferior Court John Meadows¹ who being duly sworn deposeth & saith that he knew John Perkins the applicant for a pension and he knew him in the Revolutionary War, that his acquaintance began with him in March 1782 that he knew him at the Siege of Savannah of that year. That he was a revolutionary Soldier and served with him at the least 6 months. That they were together at the Siege of Savannah and this deponent further swears that after the said John Perkins returned home he was elected Captain of the militia in 1783. That he has every reason to believe from his acquaintance with him & from what he knew & heard that he served at the several times mentioned in his declaration as a volunteer soldier previous to the time of the 6 months service for 1782.

These are to certify That John Perkins, aged Citizen is entitled to 250_Bounty according to and Back and Reserve of the General Assembly, passed at Augusta the 20th of August 1781 as per Certificate. Colonel Greenbery Lee

State of Georgia Rich, County

This is to certify That John Perkins have steadfastly done his duty, from the time of passing and Act at Augusta, to wit, on the 20th of August 1781, until the total Expulsion of the Ridge from this State; and that the said John Perkins cannot, to my knowledge or belief, the convicted of plundering or distressing the country; and is therefore, under said Act, entitled to a Bounty of 250 acres of good land, free from taxes for 10 years.
