Pension application of Robert Porter (Parter) R8352 Transcribed by Will Graves f15NC rev'd 8/9/09 & 2/18/18

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Illinois, White County Sct.} In the Circuit Court of said County October 1820

On the 9<sup>th</sup> day of October 1820 personally appeared in open court (being a Court of Record by a Statute of the State of Illinois now in force) for the Second Judicial Circuit of the State of Illinois Robert Carter aged Seventy years being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the 18<sup>th</sup> of March 1818 and the 1<sup>st</sup> May 1820 that he the said Robert Carter received a commission as Captain of a company sometime in the commencement of the year 1776 in Rutherford County in the State of North Carolina in the line of Said State under the Command of General Rutherford [Griffith Rutherford]; that he continued to serve as Captain aforesaid until about the middle of the year 1777; that he then received the commission of Major and continued to serve under said commission in that capacity until sometime about the last of the year Seventeen hundred and Seventy eight-seven Continental establishment under the said General Griffith Rutherford when he was discharged from the said Service in the said year 1777 in the State of North Carolina but that his discharge was burnt by the Tories; that he was in the battle at Kings Mountain [October 7, 1780] when Col. Ferguson [Patrick Ferguson] was defeated and that he has no evidence now in his power of his said Services.

And in pursuance of the Act of the 1<sup>st</sup> May 1820 I do solemnly swear that I was a resident citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of the Act of Congress entitled an Act provided for certain persons engaged in the land and naval Service of the United States in the revolutionary war passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me any property or securities, contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

I am unable to pursue any occupation from inability and rheumatism. I have a wife who is blind and unable to assist me aged 80 years and have no other in my family and I myself am in such Indigent circumstances as to be unable to support myself without the assistance of my Country.

The claim of Robert Porter has been examined and found inadmissible. He belonged to the militia Service only. As the law of March 18, 1818 under which he claims provides for no others' than those who served in the Continental Establishment he is not of course entitled to a Pension. The papers which you have sent here will remain on our files agreeably to the present regulations of this Department.
