## Pension application of Job Preble [Pribble] R8442 Transcribed by Will Graves

Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The depositions of Amos Milner<sup>1</sup> aged seventy-seven years and of Jesse Pigman<sup>2</sup> aged seventy-two years taken before me George Newland a Justice of the Peace in and for the said County of Union and State of Indiana on the 4<sup>th</sup> day of October 1836. The deponents being first sworn saith that Joe Preble was a Soldier in the Revolutionary war and served four years as such under Captains Jesse Pigman and Joseph Vanmetre under Colonel John Miner in the Monongahela Country in what was then called the Virginia line and at the close of the revolutionary war he the said Job Preble served in the Indian war eight or nine months and further these deponents saith not.
