Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Missouri County of Lincoln: SS

On this 19th day of May A.D. 1834 personally appeared in open Court, before the Circuit Court of Lincoln County now sitting, being a Court of Record, James Rector, a resident of Lincoln County and State aforesaid aged seventy-nine years, who being first duly sworn according to law, doth on his oath, make the following declaration in order to obtain the benefit of the Act of Congress, passed June 7th 1832.

That he enlisted in the Army of the United States on the 10th of August A.D. 1781 for the period of six months under the following named officers (viz.) Colonel Dabney and Captain Dudley: that he left said Company of Captain Dudley on the 25th day of November A.D. 1781; that he was actively engaged in serving his Country in this expedition the period of three months, that he resided when he entered the service in Fauquier County in the State of Virginia: that he was engaged in the very memorable battle of York, or the Siege of York, and was present when Lord Cornwallis surrendered his sword an Army to General Washington which battle took place on the 19th October A.D. 1781: that the place where the troops attached to the company to which he belonged rendezvoused was at Fauquier Courthouse Virginia, from thence he marched to Fredericksburg; thence to Goochland Courthouse; thence to Richmond; thence to Williamsburg: thence to York: thence to Hampton: thence to Portsmouth across the bay; thence to old Williamsburg, where he was discharged; that he had no acquaintance with any of the officers commanding the Regiment or company to which he was attached (so short was his stay in the Army:) That he has no documentary evidence that he knows of no person whose testimony he can procure who can testify to his service:

He hereby relinquishes every claim whatsoever to a pension or annuity except the present, and declares that his name is not on the pension Roll of the Agency of any State. Sworn to and subscribed the day and year aforesaid

Question 1st Where and in what year were you born?

Answer I was born in Fauquier County, Virginia on the 22nd day of August A.D. 1754. 2nd Have you any record of your age and if so where is it?

A. I have a Transcript of the Record of my age taken from my Father's Bible in a Book now in my possession.

- 3^{rd} Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?
- A. When called into service I was living in Fauquier County Virginia, since that time I have lived in North Carolina and Kentucky and I now live in Lincoln County Missouri.
- 4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

A. I was drafted

- 5th State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.
- A. Colonel Dabney and Captain Dudley worthy Regular officers, the former commanded the Regiment, the latter the Company to which I belonged. At the Siege of York and surrender of Lord Cornwallis General Washington had the command. The general circumstances of the War were such as cannot well be described, but the effects of this engagement are now seen and felt in the freedom we Americans now enjoy.
- 6th Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?
- A. I never got a discharge the Colonel of old Williamsburg I was informed when I was discharged give me a furlough for 42 days, the Treaty of peace came on, in the meanwhile, and I never returned to get a regular discharge yet I held myself in readiness and bound to fill out by term of 6 months.
- 7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.
