Pension application of Jesse Kennedy (Kenady) R93 Susan Alfred f32VA and Thomas Alfred
Transcribed by Will Graves 11/14/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 8] State of Virginia, Amherst County to wit

On this 25 day of March 1847, before me John Warwick a Justice of the peace in and for said County personally appeared Mrs. Susan Alfred, – formerly Susan Kenady, – maiden name, Dillard – a resident of said County, aged 83 years – who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefits of the provisions made by the acts of Congress passed July 7, 1838, and the 23rd of August 1842, granting pensions to widows of persons who served during the Revolutionary War.

That she is the widow of Thomas Alfred deceased of said County who was a Regular Soldier in the revolutionary war under General Washington, and was at the battle of White Plains [October 28, 1776] under him, and was his Miller at one time and that after his time as a Regular Soldier under Washington was out he enlisted in the Sea service under his uncle Captain ___ Hartshorn [? Hartsborn or Hartshom] and was in said Service at the time of the capture of Cornwallis [October 19, 1781]. She can give no further account of the above Service or the Captain's name and he was under as a regular soldier.

That she is the former widow of Jesse Kenady deceased of said County also – who was also a soldier in the Revolutionary War both as a minute man and an enlisted soldier perhaps in both cases under Captain Samuel Cabell – for she has heard her first husband Jesse Kenady say frequently that he was under Captain Cabell – who carried his men to the North in time of the revolution! And that he served a tour also after that at the Barracks in Albemarle near Charlottesville. That her memory is so bad, that the above is all that she declarant can recollect of her two husbands' Services. The first of which Kenady – she claims under in her own right, – as above and under Alfred – what pension was due him in his own right – according to the Act of July 7, 1832 [sic, June 7 1832]. She also declares that she was married to the said Jesse Kenady on the __ day of October 1786 [sic, 1780], to 1799 – the same year or before that Cornwallis was taken; that her husband the aforesaid Jesse Kenady died in said County on the __ day of __ 1799, or 1800 – it being 47 or 48 years ago that he died; That she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January 1794 – viz., at the time above stated. She further declares that after the death of her husband aforesaid, she was married to Thomas Alfred aforesaid on the __ day of April 1803 or 4, – it being only 3 or 4

years from her first husband's death – and that he the said Thomas Alfred died in said County on (or about) the __ day of __ 1832; and that she is still a widow.

State of Virginia, Amherst County to wit

n this 8 day of September 1848, before me Jesse Mundy a Justice of the peace in and for said County, duly authorized by law to administer oaths personally appeared Mr. Charles Mays a respectable resident of said County who being first duly sworn according to law doth on his oath say – That he is 62 years old, and recollects hearing his Father Joseph Mays deceased of said County say that himself and his brother George Mays deceased of Georgia enlisted during the Revolutionary War under Captain Samuel Cabell, who was a recruiting officer in said County – and was afterwards transferred and put under Captain Joseph Pannil who marched his company to Georgia and that he the deponent – Charles Mays – recollects further of having heard his father, the said Joseph Mays, say that Jesse Kennedy enlisted under Captain Samuel Cabell at or about the same time that himself, and his brother George Mays did – and was marched to the South to Georgia and that he the said Jesse Kennedy was either in the same company with his father Joseph Mays and George Mays under Captain Joseph Pannell – or that he was in the same Regiment with them under Colonel __ Elbert [probably Colonel Samuel Elbert of Georgia] - he thinks his name is that John Newman was in the same company with them – and his father Joseph Mays had his land allowed him of 350 acres for his services – and was laid off for him and that his name is found on the rolls in the Executive office in Georgia.

State of Virginia, Amherst County to wit

On this 17 day of March 1847, before me John C Whitehead a Justice of the peace in and for said County personally appeared William Cashwell² a highly respectable resident of said County who being first duly sworn according to law, doth on his oath say, – That he is 85 years old – and was well acquainted with Joseph Kennedy – or Canada – during the Revolutionary War, the same person who married Susan Dillard of said County – between the year 1785 and 90 - before deponent was; which was in 1791. That said Jesse Kennedy served in the Revolutionary war under Captain Samuel Cabell in 1775 or 76 as a minute man for several months – and he thinks, while acting in said capacity his company was down as low as Williamsburg before they returned. That while in said service he, Kennedy, enlisted in the Regular Service, for at least two years, if not three, – for he was gone from the County something like three years before he returned home from said enlistment, and that he was in the northern Service, while gone, as deponent understood. Deponent is not positive who the said Kennedy enlisted under but is impressed that it was Captain Samuel Cabell – for it was about the same time in 1776 that James Dillard, John Philips, John Tyree, Robin Hudson, William Johnson enlisted and went off to the North – as is his impression under said Cabell. Deponent may be mistaken as to the Captain, but that he is not as to the fact of said Kennedy's serving in the Revolutionary War, both, as a minute

man, and also as an enlisted Soldier. Said Kennedy, or Canada, died in said County over 40 years ago, and his widow Susan married Thomas Alfred, who is also dead.
