Pension Application of Warren Cash S10431

On this 20th day of August in the year of Our Lord One thousand Eight hundred & thirty two, personally appeared before the Honorable Justices of the Hardin County Court, (the same being a Court of record, having a clerk & seal) Warren Cash, a resident of Hardin County, and state of Kentucky aforesaid, aged seventy two years on the 4th day of April last past, who being first duly sworn according to Law, doth on his oath make the following declaration, in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832

That he Enlisted in the Army of the United States in the year 1776 in the month of August for the term of Two years – or rather, in the two year service. The regiment to which he belonged was enlisted originally for two years – one year of which had expired when this Declarant entered the service. He enlisted with Captain Mat. Jouett [Matthew Jouett BLWt1126-300], and served in the 7th Virginia Regiment which was in the fall of 1776 placed on the continental establishment [sic: 29 Feb 1776], with the following named officers. When the Regiment was first raised, it was commanded by a Col Dangerfield [William Daingerfield] – who subsequently left the same [13 Aug 1776], and it was placed under the command of Col. Alexander McClanahan [sic: Alexander McClenachan] who continued in command up to the time at which his first term of enlistment expired. There was a Major Nelson [William Nelson VAS377] belonging to said Regiment, who was subsequently advanced to the station of Lieutenant Colonel. Jouett was his Captain John Thompson Lieutenant [S31415] – who resigned, and a certain Griffin Fautleroy [sic: Griffin Fauntleroy X255] was made Lieutenant in his place. The name of the ensign of the company was Fox [probably Nathaniel Fox VAS1423]. He enlisted in Charlottesville [sic: Charlottesville] – Albemarle County, and state of Virginia, in which County and state he resided at the time, and was at Charlottesville guarding some prisoners, British & Scotch, taken at Norfolk. At this time the celebrated Tory Guthrie was in confinement in Charlottesville, in the House of old Mr. Jouett, father of Captain Mat Jouett. During his first term of Enlistment he was in no engagement or battle – he marched through Louisa County – Hanover thence into New Kent County – thence into James City County passing through Williamsburgh [sic: Williamsburg], into York County, and through Gloucester County down to Guinns Island [sic: Gwynn Island], at which place the troops had had an engagement with Dunmore and driven him out [11 Jul 1776], a short time before he (this applicant) reached that place. From Guinns Island we were marched up to York Town, from thence to Williamsburgh, where we remained until we took up winter quarters – and having after Christmass been marched back to York Town, we tarried there a few days, and were then ordered to the North passing various places too numerous to mention, until in the month of February 1777 we reached Philadelphia where the regiment was by order of Gen'l Washington Inoculated for the Small Pox.

On the 27th day of March 1777, this Applicant and many others reenlisted at Philadelphia, for the term of three years, under the same officers, in the same Company and Regiment. From Philadelphia in the month of May, We were marched through Trenton – Princeton, Somerset, and a small place called Placemain – we at lenght reached Bonbrook the same day on which General Lincoln and his men were defeated, by the British from Brunswick [Benjamin Lincoln at Bound Brook NJ, 13 Apr 1777]. From Bonbrook, we were mached to Morris Town [Morristown], where Gen'l Washington, had his head quarters during the Winter preceding. This Applicant states that he served out the term of his Enlistment and his service closed in Philadelphia where he had reenlisted in 1777; His first term of Enlistment, it will be perceived had not fully expired when he reenlisted, nor were any regular discharges given to those who did reenlist, but when his second enlistment was out, he was regularly discharged by Col.


Febaker [sic: Christian Febiger VAS675], to whom that duty was assigned by Gen'l. Washington – And the troops & company to which this applicant belonged, were marched from Philadelphia to Alexandria by Capt. Overton, who presented the discharges to the troops.

He states that in the year 1784, he removed to Kentucky, in which state he has resided ever since. That in removing, being greatly exposed to rain & storms, he lost his discharge as he supposes – never having been since able to find it. He states that beside several slight skirmishes with the enemy in which he was engaged during his second Enlistment, he was in two general battles – to wit – The Battle of Brandywine, on the 11th Sept. 1777 – and the Battle of Monmouth, New Jersey on the 28th June 1778 in each of which, he honestly discharged his duty as a soldier.

He hereby relinquishes every claim whatever to a pension or an annuity except the present – And he declares his name is not on the Pension roll of any Agency in any state whatever.

I do Certify that I was first Lieutenant in Cap'n. Matt Jouett Compiney in the seventh Virginia Regiment in the year one thousand seven hundred and seventy six and that Warren Cash was one of the soldiers, and that while I remained in the army said Cash behaved as a good soldier and after the war was over, he said Cash lived a near neighbour to me for some years, and I never heard any thing but he said Cash had performed his term of service well John Thompson

At a Court held for Fluvanna [undeciphered] the 3rd day of Oct 1782 Warren Cash came into Court [illegible] it satisfactorily appear that he enlisted as a Soldier, in the Service of the [illegible] States for the Term of three years, and served the same, and was legally discharged [illegible] of his discharge [illegible] date Jan'y 20 17 [illegible] are of Opinion that he is entitled [illegible] which is ordered to be certified a Copy Jno. Timberlake D'y Clk

State of Kentucky } I Edmond Gardner a Justice of the peace in the County and State aforesaid do hereby Certify that Joseph Timberlake [S37491] a private in the 7th Virginia Regiment Virginia Continental line is a Creditable witness and that he personally appeared before me in my County and State aforesaid and made oath that he was well acquainted with Warren Cash a private Soldier in the Revolutionary War Virginia Continental line and that the said Warren Cash served as a private under the command of Capt Mathew Jouett and that the said Warren Cash served in the said Company of Capt Mathew Jouett three years in the 7th Regiment and that the same Warren Cash is now living in the County of Hardin and State of Kentucky Given under my hand and seal this 17th day of April 1835

Memorial of Warren Cash to the Executive of Virginia [23 Apr 1835]

Your Memorialist respectfully represent to the Executive of Virginia that he enlisted on the 27 of March 1777 in the Virginia Continental line in the company commanded by Capt. Mathew Jouett in Col Alexander McClanahan 7th Regiment for three years Your memorialist served upwards of three years and was honorably discharged on the [undeciphered] March 1780 from the company then commanded by Capt [undeciphered] McClanahan 7th Regt. Your Memorialist had served in the Virginia line one year

previous to his enlistment in March 1777 under Capt Mathew Jouett. Your memorialist has never received the bounty land promised him by the act of Virginia and requests that the Executive of Virginia will direct the Register of the land office of Virginia to issue to my attorney in fact John P. DuVal the warrant for the bounty land due me for three years services your memorialist further states that he resides in the county of Hardin State of Kentucky. Signed Warren hisXmark Cash
