[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The State of Alabama Fayette County

On this 1<sup>st</sup> day of October 1832 Personally appeared before Walter Haskins Judge of the County Court of Fayette County Thomas Glaze of said State and County aged about eighty-one years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June the 7th 1832. That he enlisted in the Army of the United States in the year 1776 in February and served in the 2nd Regiment in Lancaster District South Carolina under Captain George Wade who was commanded by Colonel Sumpter [sic, Thomas Sumter] and General Moultrie [William Moultrie] and marched from Lancaster District to Charleston South Carolina and from thence to Sullivan's Island and from thence to Haddrell's Point and thence to Bolton's landing and thence to Charleston South Carolina and thence to Seneca old town against the Cherokee Indians and had several scrimmages with the Indians, and from thence to Ninety Six and from thence to Ripley's Fort on the head of Saluda River and was there stationed for several months and from thence to Santee River towards Charleston and from thence to St. Mary's in Florida and from thence back to Santee and from there discharged in June 1777 which discharge is lost or mislaid so that it cannot be found. I again entered the service in Lancaster District South Carolina sometime in July 1780 as Captain of Colonel John Marshall's Regiment and was commissioned or brevetted by him and was commanded by General Thomas Sumter and marched at different times on scouting parties in South Carolina, and marched to Camden South Carolina and thence on to Catawba and was in Sumter's defeat [Battle of Fishing Creek, August 18, 1781] and then the Army was scattered and about the 25<sup>th</sup> of October 1780 the Army collected again on the Catawba and were on different scouting parties until sometime about October 1782 when I resigned my commission which commission is also lost so it cannot be found. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of any agency of any State, Sworn to and subscribed the day and year aforesaid. State of Alabama, Fayette County: Circuit Court for said County Fall Term 1834

On this the 27th day of October A.D. 1834 personally appeared in open court before the presiding Judge of said Court Thomas Glaze a resident of said County aged Eighty-two years who on his oath makes the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June the 7th 1832 -- to wit

He enlisted at the age of 25 years in the service (after having first received the bounty), for fifteen months under General Thomas Sumpter [sic, Thomas Sumter], Colonel William Henderson, Major William Brown and Captain Wade in the year 1776 -- That he was with the land forces at the Battle of Sullivan's Island that he received the bounty from George Wade who was then acting as Captain -- that this was in February of 76 -- and that he continued in active service ranging the Country and taking every advantage that opportunity would afford -- that part of which time their attention was turned towards the Indians on the Frontiers. This applicant served out the Tour and was discharged Honorably by General Sumter at a place called Taucaw on Santee River on the 6th day of June of the year '77.

Previous to the above Tour this applicant had been engaged for some time in Scouting parties that ranged the Country & gave the enemy as much trouble as possible but was only say one month in actual service in an embodied Corps -- was discharged by Colonel Wofford [perhaps William Wofford] at a place called Liberty Hill.

The 2nd Tour this applicant volunteered under Colonel Joseph [illegible last name], Capt. Middleton McDaniel this applicant was living on Catawba River in South Carolina during the whole of his Service -- this Tour commenced in the beginning of '79 and continued 2 months and this applicant was honorably discharged rather the whole company to which he belonged & the forces generally were discharged he being then an officer himself did not receive any discharge. This applicant at the commencement of this tour last mentioned was appointed by Captain McDaniel Orderly Sergeant and before the Tour ended was promoted to the office of Ensign the forces which this applicant belonged marched in a south direction [text missing as a result of the paper being cut] Lincoln [Benjamin Lincoln] at Purrysburg where they had a slight [text missing as a result of the paper being cut] Enemy -- here the two forces again separated & Lincoln put his forces on the road towards Charlestown South Carolina the remaining forces under the command of Colonel Kershaw [perhaps Eli Kershaw] marched up the Savannah River to join General Williamson [Andrew Williamson] & was discharged about fifty miles below Augusta on the Savannah River.

The 3rd Tour of service or services was rendered by this applicant as a Captain having received a brevet from Colonel John Martial [sic, John Marshall] over a Horse company of militia and this applicant was still under the command of General Sumter this Tour of service commenced in the latter part of the year 1781, and continued until the close of the war during this last service this applicant was in the Battle of Rocky Mount [July 30, 1780] -- the Battle at the Hanging Rock [August 6, 1780] and the taking of Rugeley's Fort [December 4, 1780] there was also several other skirmishes during this period of service not worth noticing. This applicant states that from the Fall of 1781 to the close of the war he was commander of a light Horse company as before stated and in actual service to the best of his recollection eighteen months for which he claims a pension –

This applicant states that from old age and the consequent loss of memory he cannot state precisely the length of his service but to the best of his recollection he served not less than the periods below mentioned (to wit)

One month under Colonel Wofford & Lieutenant Doughty that he was in active Service -- Exclusive of little scouting parties

1<sup>st</sup> regular Tour was under General Sumter Colonel Henderson & Major Brown & Captain Wade -- enlisted in the 2nd Regiment of provincials, received a bounty and served out the Tour of 15 months and was honorably discharged.

2<sup>nd</sup> Tour was under Colonel Kershaw and Captain McDaniel served 2 months -- was acting part of the time as Ensign -- the forces were then discharged

3<sup>rd</sup> Tour was under General Sumter & Colonel Marshall served as Captain of militia horse & continued eighteen months when the war closed --

The first tour this applicant enlisted & he believes he can prove his service by Thomas Stanford<sup>2</sup> of Marion County in this State. The remainder of his service he knows of no person by whom he can prove his services by

He hereby relinquishes every claim to a pension or annuity whatever & declares that his name is not on the pension roll of the agency of any State.

The names of the officers with whom he served are stated in his declaration the 1<sup>st</sup> enlistment was in the 2nd Regiment of Provincials -- the other service was in the Militia -- Received discharge 1<sup>st</sup> term of service from Colonel Wofford – the 2<sup>nd</sup> term from General Sumter all the other terms of service he acted as an officer did receive a commission or Brevet for Ensign from Colonel Kershaw for Captain from Colonel Marshall received a commission or Brevet for Captain states that Jesse Vanhoose and Flemming Thompson is well acquainted with him and can testify to his character for truth & veracity as well as the reputation of his having been a soldier of the Revolution.

State of Alabama, Fayette County: Circuit Court for said County April Term 1835

Personally appeared in open Court Thomas Glaze who after being duly sworn deposeth & saith an answer to the objections made by the War Department states that he knows of no other person living by whom he can prove his services by other than the individual whose affidavit has accompanied the papers.

This applicant answers the objection to that part of the deposition relative to his continuous service in 1781 by stating that the British at that time had taken the country & that this applicant was deterred from remaining at home in consequence of the fact that he considered it dangerous for him to be found at home as his life was severely threatened by the Enemy.

As to that part relative to his duties as an officer this applicant cannot prove matters as required by the Department, there being no one in his knowledge now living by whom he could prove the matter.

The reason why this applicant did not long since under the Back of 1818 apply for a pension was that he considered himself independent & able to support himself.

To the last suggestion made by your Department -- Your applicant answers that his brother Samuel Glaze did enlist with him & served the whole time that this applicant served and that his said brother has long since Departed this life.
