Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." ## State of Kentucky County of Logan: SS

On this 13th day of August 1832 personally appeared before the Judges of the Circuit Court of said County, Leonard Page a resident of Logan County and State of Kentucky, aged Sixty-nine years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress, passed June 7th 1832 – That he enlisted in the Army of the United States about August in the year 1778 with Captain Richard White and served in the Virginia Guards, that guarded the Convention Troops of prisoners taken by General Gates [Horatio Gates] and Stationed at the Barracks in the County of Albemarle in the State of Virginia; under the following Officers, Captain Robert White, Colonel Taylor [Frances Taylor] and left the service about first of April in the year 1781.

He served only one term of enlistment, having enlisted during the stay of the above mentioned prisoners at said Barracks. He resided in Goochland County Virginia at the time of his enlistment and enlisted at the said Barracks in Albemarle County. Captain White's Company was principally from Louisa County Virginia. Captain Rice, Captain Timberlake; and Captain Burrell's Companies also served at the said Barracks.

The said Page remained in Captain White's Company and at said Barracks during his Service, except about two months; that he marched and guarded said prisoners from said Barracks to the Town of Winchester Virginia, where he remained the said 2 months and returned home. He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the pension Roll of any Agency of any State.

I Elizabeth Saunders do hereby certify that I am well acquainted with Leonard Page who has Subscribed in Sworn to the above declaration and that I resided in his Father's family at the time [he] enlisted in the Revolutionary War and remained there until the close of said War – that he is 69 years old, that he enlisted in the Army of the Revolution in the month of July or August in the year 1778 & that he remained in said Army until the Spring of 1781 – that he resided in Goochland County Virginia at the time of his enlistment. That he is now & has been a clergyman for the last Thirty years – Sworn and subscribed the day & year aforesaid.
