Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Garrard County Sct.

On this 20<sup>th</sup> [?] day of August 1832 personally appeared in open Court before the Justices of the County Court held in and for the County aforesaid and now in Session, William Parks a resident of the County of Garrard and State aforesaid aged upwards of 77 years who being first duly sworn according to law, doth on his oath, make the following declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832.

That he joined the Army in the War of the Revolution in the militia in Montgomery County as a volunteer in the State of Virginia in the summer of the year 1776, (the month he does not precisely remember) under Captain John Montgomery, his General was by the name of Christy [William Christian], (he believes William Christy) his Colonels were Russell and Arthur Campbell. He engaged for a certain period of time, but he does not now remember the time. That they marched against the Cherokee Indians and after returning from the expedition, he assisted in erecting a Garrison on Holston [River], where a Treaty was made with the Indians. That he served faithfully the period of thirteen months and was honorably discharged in the year 1777 which discharge has long since been destroyed. That afterwards he volunteered for a short period under Captain John Montgomery [PERHAPS a mistaken reference to Capt. James Montgomery who is known to have been in the skirmish on Reedy Fork on March 7, 1781], Colonel William Preston was his Colonel and served about one month more, during which time he was in the skirmish at Alamance in North Carolina our party was commanded by Colonel William Preston, <sup>1</sup> and four days afterwards, he was in another engagement at the Ready Fork [Reedy fork] of Haw River in the aforesaid State of North Carolina.

He hereby relinquishes every claim whatever to a pension except the present and declares that his name is not on the pension roll of the agency of any State.

appeared before me Jacob Dooley [?]<sup>2</sup>aged 77 years and made oath that he was a soldier at the long Island in the State of Virginia he thinks in year 77 and that on that campaign he saw William Parks and was acquainted with him: but whether he Parks was a private or Sergeant he knows not, he Doolin<sup>3</sup> was discharged & left Parks there, how long Parks served he knows not. Given under my hand this 6th of November 1832.
