The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Christian County: SS

On this 3rd day of September personally appeared in open court before the Justices of the Christian County Court in the State of Kentucky John Harlow a resident of the County & State aforesaid aged (81) Eighty-one years who being first duly sworn doth on his oath make the following declaration in order to obtain the benefit of the provision of the act of Congress passed June 7, 1832.

John Harlow states that he was born June 7, 1751 in Hanover County State of Virginia about 20 miles from Richmond. When young his parents moved to Louisa & subsequently after a lapse of some years (he cannot recollect) moved to Albemarle County. Has a record of his age in his house – was drafted in Albemarle & placed under Colonel George Mathews – Captain Thomas Collins & Lieutenant Ned Garland [Edward Garland] and thinks his General officer was a Frenchman named Fayette [Lafayette]. From Albemarle was marched to Richmond & from Richmond 20 miles lower down towards Williamsburg which had been visited by Arnold [Benedict Arnold] when he returned to his shipping & when his forces were taken up James River he (Harlow) was still kept stationed about 20 miles below Richmond. In that station he was taken sick with the Rheumatism and was ultimately sent to the Hospital at Richmond where he was discharged by the attending Physician, though barely able to move & did not reach his home (though laboring hard every day to do so) for three weeks after the company with which he served. He was drafted sometime early in the season: the year he does not now recollect & was discharged after a service & sickness of six months. His discharge he gave his brother to endeavor to procure some thing for him about forty years ago but never got any thing & his discharge he supposes is lost. He had three Brothers at the taking of Cornwallis shortly after his return home who, if he knew where they were, or were alive, could prove his service & perhaps produce his discharge. He never received a cent for his service rendered.

From Albemarle he moved about 35 years ago to Botetourt County where he lived about 30 or 31 years & from there he moved to this County where he now resides.

He hereby relinquishes all claim to a pension or annuity except the present & declares that his name is not on the pension roll of any agency of the United States.
