Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Isaac Kennedy, Private, in the Army of the Revolution Inscribed on the roll of North Carolina at \$3 increased to \$4.80 by Law of 24th April 1816 Formal certificate issued 11th September, 1821 & sent to John A. Cameron Esquire, Paid Br.

[State of North Carolina], County of Cumberland

On this 4th day of September 1821 before me the Subscriber a Justice of the peace for the said County of problem personally appeared Isaac Kanedy [sic] who on his oath declares that he is the same person who formerly belonged to the company commanded by Captain John Willis and the Regiment commanded by Colonel ____ in the service of North Carolina that his name was placed on the pension roll of the State of North Carolina and was there by transformed on to the Pension list of the United States.

Mr. Kennedy is now very old and infirm and his Memory has much failed him. He does not recollect the Colonel who commanded his Regiment: he is the same person who has been drawing a pension at this office for many years.
