[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Montgomery County: February 1<sup>st</sup> day 1820

This day George Bledsoe a Pensioner of the United States made oath in due form before me Edmund DeBerry one of the acting Justices of the Peace for said County that he never has obtained from the Pension office of the United States a certificate of his being a Pensioner and that he had no knowledge until lately of its being necessary for him to obtain such certificate. Sworn to and subscribed before me the day above mentioned.

[Text of letter from the War Department to be used in response to inquiries regarding this veteran.]

\*Reference is made to your letter in which you request the record of George Bledsoe, etc.

The Revolutionary War records of this office show that George Bledsoe served as a private in that war.

Because of disability resulting from wounds or exposure during service in the Revolutionary War, this soldier was pensioned at the rate of \$60 per annum from September 4, 1794, under the act of April 20, 1796. His name was placed on the North Carolina pension roll. The papers in his early application for pension were destroyed by fire when the War Office was burned in 1800, hence, this office has no details of his wounds horse service, or place of residence at enlistment, or information in regard to his family.

February 1, 1820, this soldier made application for a formal pension certificate. He was then a resident of Montgomery County, North Carolina. His pension was continued under the acts of April 24, 1816, and March 3, 1819. He died July 1, 1831. His age, place of birth and names of parents are not shown. The soldiers signed George Bledso but his name was born on the pension rolls as George Bledsoe.

No other claim for pension of a George Bledsoe has been found in the Revolutionary War records of this office, under any spelling of the name.

In the American State Papers, Class 9, page 164, under the caption, "A statement of certificates transmitted to the War Office of the United States by the Judge of the District Court for the District of North Carolina, an invalid pension applicants examined by him", it is recorded that George Bledsoe served as a Sergeant in the Georgia Dragoons, was wounded in the left leg by a musket ball March 19, 1779, which disabled him from making a livelihood by labor, at his residence was Franklin County (state not named), that he was entitled to full pension, and that no rolls were in the office (being War Office). It is shown, also, that the "evidence was complete", upon the basis of which it might be assumed that George Bledso who receive the pension from 1794 was identical with the George Bledsoe recorded in the American State Papers. This office has no proof, however, upon which to make the definite statement that they are one and the same man.
