Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of North Carolina Mecklenburg County: application for a Transfer

On this 30th day of September 1826 before me the subscribing Justice of the Peace for the said County of Mecklenburg Personally appeared Alexander Haynes who on his oath declares that he is the same Person who formerly belonged to the Company commanded by Captain John Bromfield in the Regiment commanded by Colonel Robert Irwin in the service of the United States, that his name was placed on the Pension Roll of the State of North Carolina, that he now resides in York District South Carolina where he has lived for 30 years and where he intends to

live as long as he lives, and as he understands he can no longer received his pension in North Carolina wishes his name transferred to South Carolina and hereafter to receive his pension in his own State he has no other reason to offer for removal only that immediately after the war he settled where he now lives he was raised in Mecklenburg North Carolina and remained at his father's for ten years after he was wounded.
