Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undecipherad' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

I certify, that, in conformity with and the Law of the United States, of the 31st May 1830, Daniel McElduff, late a Lieut. in the Army of the United States is inscribed on the Pension List, Roll of the West Tennessee agency, at the rate of \$15.11 per month, to commence on the 31st day of May 1830, being the amount which heretofore under a former pension certificate he has received.

Given at the War Office of the United States, this 2nd day of June 1830.

Sirs:

With reference to your recent telephone request for information concerning Daniel McElduff, a pensioner of the revolutionary War, West Tennessee agency, you are advised that the above named pensioner served under Col. William Thompson of South Carolina. He was transferred from the Georgia agency to the West Tennessee agency on January 11, 1820. The last payment of pension covering the period from March for, 1828, to September 4, 1829, was made

When the WPA writers assigned file numbers to the pension applications, \$155 was assigned to what appears was ultimately determined to be two different individuals. I have separated the transcriptions of these two men and have assigned McElduff the designation S155x.

to the pensioner at Nashville, Tennessee, on September 4, 1829.

The records of this office further show that on February 26, 1830, the pensioner was examined by a board of physicians who found him to be feeble and totally disabled. At that time he was residing in Franklin County, Tennessee, and had resided there 14 years.

No further information has been found of record in this office.
