Pension application of John Dabbs S16359 Transcribed by Will Graves f21NC rev'd 2/14/10 & 4/22/20

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

On this tenth day of October in the year 1832 personally appeared in open court before the Superior Court of the said State & County of DeKalb, now sitting, John Dabbs a resident of said County and State, aged Seventy years, who being first duly Sworn according to law on his oath makes the following declaration in order to obtain the benefit of the Act of Congress passed June the 7<sup>th</sup> 1832. That he entered the service on the United States under the following named officers and Served as herein Stated. As well as he recollects about three months after Genl Gates' defeat [Battle of Camden, August 15-16, 1780]] he entered the Service as a Volunteer under Capt. Bogan [Patrick Boggan] & Col. Thomas Wade officers of the Militia, the date not recollected, for three months and after the expiration of his time he volunteered for another three months tower under the same officers & under the command of Genl Rutherford [Griffith Rutherford], he performed part of the Service in North Carolina which was his place of residence and part in South Carolina he was in a skirmish at what was called the brick house [November 15, 1781] near Wilmington he recollects of no other battle he was in during the Revolutionary war. He states he has no documentary evidence of his service never having received any discharge, he further states he can prove all his service which is six months by Thomas Slay<sup>2</sup> a resident of this State and County. He hereby relinquishes every Claim whatever to a pension or annuity except the present and declares that his name is not on the pensions roll of the agency of any State.

Personally appeared in open court on the day aforesaid Thomas Slay a resident of said State & County who after being duly sworn Deposeth and saith that he was acquainted with John Dabbs who has sworn to & subscribed the foregoing declaration in the Revolutionary war the said Dabbs served in one company and he deponent in another and they were frequently together and he knows of his own knowledge of the said Dabbs having served about six months in the Army of the States of South Carolina and North Carolina under the command of General Rutherford and knows of the said Dabbs having been in the Skirmish at the brick house near Wilmington.

State of Georgia DeKalb County On this Eighth day of July in the year 1833 personally appeared in open Court before the Inferior Court of the said County of DeKalb now sitting John Dabbs a resident of said State & County aged seventy-one years, who being first duly sworn according to law, doth on his oath make the following declaration in addition to the one which he made at the October term of the Superior Court in aforesaid County, in order to obtain the benefit of the act of Congress passed on the 7th of June 1832. That he entered the service of the United States in the latter part of the year 1780 to the best of his recollection, as a volunteer in Captain Bogan's company under the command of Colonel Thomas Wade an officer of the militia, that he served at that time three months, he further states some time in the summer or fall of the year 1781 he served another tour of three months under the same officers commanded by General Rutherford. This service was performed partly in South Carolina & partly in North Carolina and he was in a skirmish at the Brick house near Wilmington. He further states that he was born in Charlotte County in the State of Virginia the twenty second day of March 1762 -- has no record of his age. He was living in Anson County State of North Carolina when called into service -and removed from that place to DeKalb County Georgia [word obliterated] years ago where he has resided ever since. He states that he is known to Thomas Grogan, Tansay Garman, Alfred Edwards & Jordan Webb who reside in his immediate neighborhood & who can testify as to his character for veracity and their belief of his services as a soldier of the Revolution.

Georgia DeKalb County} Personally appeared before me Thomas Slay who after being duly sworn deposes & saith that whilst he deponent was a soldier in the Revolutionary war he was acquainted with John Dabbs who has made the foregoing declaration -- that said Dabbs served in one company & deponent in another, that he saw him frequently. He knows that he served two tours of duty but cannot say how long he served.
