Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Indiana County of Fountain SS

On this 21st day of Marched 1833 personally appeared at the house of Deponent in Shawnee Township Fountain County & State of Indiana before me Jonathan Burch sole Judge of the Probate Court of said County of Fountain (being a Court of Record) Tobias Mosier a resident of said Township County & State aged about eighty-five years (precise age not recollected by Deponent, but upwards of eighty-four) who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832. That he entered the service of the United States in the early part of the fall season year not recollected but soon after the beginning of the revolutionary war & after the Declaration of Independence, as a volunteer under Captain John Barnet [John Barnett], in the Regiment commanded by Colonel Litterell [sic, John Luttrell of Chatham County North Carolina] (Christian name not recollected) in the militia of North Carolina: that he does not now recollect the term of his enlistment but continued in service until the ensuing spring or close of winter in all more than six months according to the best of deponent's recollection, & constantly when he was honorably discharged but received no written discharge -- that he enlisted as aforesaid as a private at the barracks at Timothy Terrill's old place between Haw & Deep rivers in what Deponent thinks was then Orange County State of North Carolina perhaps afterwards Randolph County or it may have been Randolph at that time he is not certain. That immediately after his enlistment he with some others [were] sent by order of the Commissary some 15 or 20 miles north for provisions (beef) & on his return in a few days the Regiment had marched away from the barracks, & deponent thereupon consulted with a militia officer there, a Major John Hines [John Hinds], about following them, and as the Tories were then thick he was advised to await their return at the barracks where there were then a few soldiers -- that in about 2 weeks the Regiment returned, & Deponent with the other men of the Regiment made several short marches during that fall & winter in pursuit of & to watch the Tories but no other expeditions were made by them. Deponent thinks there was or had been a Major Outlaw in command in the same Regiment -- he also thinks that while he was in service a regular officer by the name of Pate or Peyton (rank not recollected) made a requisition for men upon his Colonel but for some cause did not obtain them. Deponent was in no battle. Deponent recollects the name of Colonel William O'Neal a regular officer in that part of the country. Deponent at the time of his enlistment lived about 15 miles from said barracks in what was once Orange & afterwards became Randolph County in North Carolina which County he then was Deponent does not

recollect -- he was discharged at said barracks -- Deponent has no documentary evidence to prove his service, nor does he know of any living witness by whom he can prove it. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the Agency of any State.

Deponent further states that he lives about 12 miles from Covington the seat of justice of the said County of Fountain and owing to old age & bodily infirmity is not able to attend there to make this declaration in open Court.
