Pension application of Jesse Peters S16506 Transcribed by Will Graves f22GA 7/15/09: rev'd 11/13/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Georgia Oglethorpe County In the Superior Court September Term 1818

Jesse Peters came personally into open court & made oath that on the eighth day of October 1776 this deponent was recruited in the County of Wilkes by Captain John Dooly who was recruiting for the Continental line, & after his enlistment was attached to the company of Captain Burwell Smith of the 3rd Regiment of the Georgia Regular Troops, this deponent does not at present recollect the name of the Colonel who commanded the Regiment. That he enlisted for the term of eighteen months & faithfully served the same, as will appear by his discharge hereto annexed. And this deponent further saith that he is now old & infirm & from his reduced circumstances, requires the aid of his country for his support.

State of Georgia County of Carroll SS

On this second day of September 1833 personally appeared before the Court of Ordinary for said County Jesse Peters a resident of said County & State aged eighty-one years, who being first duly sworn according to law, doth on his oath make the following declaration or statement in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832. That he enlisted in the Army of the United States in the year 1776 with John Dooly a recruiting officer and served in the 3rd Regiment of the Georgia line under the following named officers Colonel Scrivin [sic, James Screven] Colonel White & Colonel Malmedy [Francis de Malmedy, Marquis of Bretagne], Captain Burrel Smith Captain Oddleson [perhaps, Lt. Benjamin Odingsell] & Captain Nash [perhaps Clement Nash]; and continued to serve 2 years and 11 months as a private and was discharged by General Locklin McIntosh [sic, Lachlan McIntosh] at Augusta in 1779, he resided in Wilkes County in Georgia when he enlisted, he marched through the Country from Wilkes County to Savannah thence to Tiby Island [sic, Tybee Island] thence on an expedition on board the Congress Rogally [sic, Congress, a row galley] -- under Captain Unogate [John Newdigate] to the mouth of the St. Mary's River thence back to Savannah thence to Sunbury thence to Midway Meeting house thence to Purrysburg South Carolina thence to Augusta Georgia and joined General Ash [sic, John Ashe] and was at Ashe's defeat at the mouth of Briar Creek -- he made his escape & joined General Linkhorn [sic, Benjamin Lincoln] at

Black Swamp, thence to Augusta -- he was then marched through South Carolina in pursuit of the British Army to Stono ferry and was in the a battle at that place [June 20, 1779] after which he marched back to Augusta & was discharged as above stated. That he has been previously on the pension roll under the act of 1818 and has been struck from the same. That he resided in Oglethorpe County in this State when his first application was made & resides in this County now. That he sent his discharge to the department at the time he first applied & supposes it on file there. He hereby relinquishes every claim whatever to a pension or an annuity except the present and he declares that his name is not on the pension roll of any agency in any State --

He answers to the interrogatories <sup>1</sup>as follows one. In Craven County North Carolina in the year 1753; 2nd he has record of age but lost it in revolution; 3rd in Wilkes County (or the territory now forming it) in this State, has lived since in Wilkes, Oglethorpe & Walton and now in Carroll County all in Georgia sd: 4th he enlisted in the service voluntary; 5th General Lincoln Colonel Malmedy and Captain Perry recollects no more but what is stated in the body of Declaration; 6<sup>th</sup> he received a discharge from General McIntosh which he sent to the war department by Mr. Cobb of the House of representatives from this State in his former application & has never seen it since; 7th William S. Parr & Joseph Little -- no clergyman in his power to procure.

The Bearer Jesse Peters a Soldier of the Third Georgia Regiment is hereby Discharged from the Service he having served faithfully during the time of his Enlistment for which he is entitled to every advantage & Emolument promised in such law [?] by his Country -- and to prevent every Imposition here follows the Description of the said Jesse Peters aged 27 years about 5'9" high, florid Complexion red hair, blue Eyes, born in Craven County State of North

<sup>1&</sup>lt;sup>st</sup> Where and in what year were you born?

<sup>2&</sup>lt;sup>nd</sup> Have you any record of your age and if so where is it?

<sup>3&</sup>lt;sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

<sup>4&</sup>lt;sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if a substitute, for whom?

<sup>5&</sup>lt;sup>th</sup> State the names of some of the regular officers who were with the troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

<sup>6&</sup>lt;sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it? 7<sup>th</sup> State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.
