Pension application of John Connelly S16719 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Missouri County of Boone: Sct.

On this first day of October 1832 personally appeared before the Circuit Court of the County of Boone and State of Missouri aforesaid John Connelly a resident of the County and State aforesaid aged about Seventy years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7, 1832.

That he was enlisted in the Army of the United States in the year 1781 (he thinks in the month of May or June) by a recruiting Officer named Cleggett in the town of Piscataway, in Prince George's County, Maryland and was marched to Annapolis, where he was placed under the command of Capt. Williams, commanding the 1st company of the 3rd Regiment, commanded by Col. Peter Adams – was marched from thence to Williamsburg, in Virginia, where he remained stationed a short time – marched thence, in the Army of General George Washington, to Little York, in Virginia, was in the Siege and at the Capture & surrender of Cornwallis [October 19, 1781] – Marched thence to South Carolina and formed a junction with the Army of General Nathaniel Greene [Nathanael Greene], at a place called "Round O." Here he was attached to the Second Regiment (so called) under the command of Col. John Stewart – and was under the command of Lieut. Edward Compton, and Ensign Samuel Hanson – and was marched to a place called Pond Pond [South Edisto River] – thence to Bacon's Bridge – thence to a position near Ashley River, where we remained encamped until the latter part of the fall or the beginning of the winter of 1781 – [paper damaged and text rendered illegible] the command of Major Roxburgh to Annapolis in the State of Maryland which we reached in the winter of 1783, - remained stationed at Annapolis, a short time and marched from there to Fredericktown in the State of Maryland, where we were employed in guarding the Hessian Prisoners, taken during the War – where we remained until the prisoners were discharged, when I obtained a furlough from Lieut. John Linn (being the principal in command at the time) permitting me to return to my place of residence, which was in Charles County Maryland. This was the only paper I received – there being at the time no person at that place to grant certificates of discharge.

He hereby relinquishes every claim whatever to a pension or an annuity except the present, and he declares that his name is not on the pension roll of any Agency in any State. Sworn to and subscribed the day and year aforesaid S/ John Connelly

[p 7: On April 2, 1855 in Boone County Missouri, Benjamin Conolly and Sanford Conolly both of Boone County filed a power of attorney in which they state they are the children of John Connelly deceased; that their father was a revolutionary war pensioner.

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for service as a private for 2 years in the Maryland Continental line.]
