## Pension application of Benjamin Darby S16758 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Alabama Clarke County}

On this Sixth day of November 1832 personally appeared in open court before the honorable Samuel Wilkerson Judge of the orphans Court of Clarke County and also Judge of the County Court now sitting as Judge of the orphans Court Benjamin Darby resident of said County & State aged eighty-four years on the 8th day of February last past who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed the 7th day of June 1832.

That he entered the service of the United States under the following named officers and served as herein stated. That his first Service was under Daniel Green a Captain in the Militia service and Henry Ferguson, which service was rendered before the British took Augusta in Georgia and that he served in that tour more than six months, the second term of service was under John Ryan a Captain in which service he was in the Battle of Stono [June 20, 1779]<sup>1</sup>, 30 or 40 miles above [?] Charleston South Carolina that Captain Ryan was in the militia service of South Carolina and that he served in that trip two months and that Andrew Pickens was Colonel commanding at the Battle of Stono.

The third term of service is was under Captain John Ryan & commanded by Leroy Hammond as Colonel, in which Service he served about three months and he was called into service again under Captain William Swearingen commanded by John Purvis as Colonel, his served but a short time say about 15 days. That he was at the retaking of Augusta in Georgia<sup>2</sup> and was commanded by John Ryan as Captain.

I hereby relinquish every claim whatever to a pension or annuity except the present, and declare that my name is not on the pension roll of the agency of any State

I have none

3 Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

I was living in South Carolina Barnwell District when first called into service. I lived in

Edgefield District about 20 years after the war, I live in Monroe & Clarke County Alabama the balance of the time, and do now reside there.

How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

I was always drafted

Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

I never received a written discharge.

I am known to Hezekiah Bussey who resides in the same neighborhood with me.

[Hezekiah Bussey, a clergyman, and William Hill gave the standard supporting affidavit.]

[Facts in file: Charlotte Gliddon, daughter of Benjamin Darby, was living in Mobile Alabama in 1855; in a document dated 1859 there is reference to 2 women who are children of the veteran but their names are not given. The veteran died in Clarke County Alabama.]

[Veteran was pensioned at the rate of \$38.32 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 11 months and 15 days in the South Carolina State Troops.]
