On this tenth Day of December 1832 personally appeared in open Court before the worshipfull Justices of the Casey County Court now sitting Julias Glazedbrooks a Resident of Casey County State of Kentucky aged eighty years the 15th Day of April last who being first Duly sworn according to Law doth on his oath make the following Declaration in order to obtain the benefit of the act of Congress passed June 7th 1832 That he entered the services of the United States under the following named officers and served as herein stated that he enterd the services of the United States on the tenth Day of June 1780 in the County of Charlotte State of Virginia the place of his then Residence as a Drafted Militia Man in the Company of Capt Thos Williams [Thomas Williams] who marched us on through Virginia by Halifax Courthouse & through Pyttsalvaney Cty [sic: Pittsylvania County] to the State of North carolina to Hillsborough where he joined the headquarters of General Stephens [sic: Edward Stevens] Brigade, the officer Commanding the Regiment not Recollected But Recollects Colos Holt Richardson [Holt Richeson] & [James] Lucas & Major Moriss & [William] Boyce &c with whom he served Dureing his time of service in the State of North Carolina until Discharged at Gilford [sic: Guilford] Courthouse in said state some time in the last of november following makeing his time of services five months and that he entered the said service the second time in the month of July 1781 as a Drafted priveat in the said County of Charlott Virginia where he still resided in Capt Andrew Wallass [sic: Andrew Wallace] Company who marched us to Mobbin hills [sic: Malvern Hill 15 mi SE of Richmond] in Va to the Headquarters of General Stephens with whom he served a tour of three months in which time General Stephens march us through Richmond to King William County Virgia where he stationed us for awhile then marched us to Williamsburgh [sic: Williamsburg] where he was Discharged for a tour of three months the Colos was [St. George] Tucker & holt Richardson, he has no Documentary, and has herewith sent all the personall evidence he can at this time procure who can testify to his sevices [not found in file]

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State Sworn to and Subscribed the Day and year aforesaid

NOTE: On 20 March 1841 Julius Glazebrook applied to have his pension transferred to Indiana, having moved to Putnam County because "[h]is great age and feeble health required that he should be carefully treated, and he has a son residing in said County of Putnam with whom he now resides."
