## Pension application of Thomas Hampton S16842 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Missouri County of Lincoln: SS November Term 1832

On this sixth day of November in the year A.D. 1832 personally appeared before the Justices of the County Court within and for the County and state aforesaid Thomas Hampton a resident of the town of Troy, County and State aforesaid aged seventy-two who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provisions made by the act of Congress passed June 7<sup>th</sup> 1832.

That he enlisted in the Army of the United States within the year 1777 with Lieutenant Woolfolk and served in the 2<sup>nd</sup> Regiment of the Virginia State line under the following named officers Colonel Brent and Major Quarles were the field officers and Captain Ambrose Dudley Lieutenant Long and Ensign Triplett the Company officers under whom I served I resided in Caroline County Virginia when I enlisted in which County I was born. I left the service (agreeable to the best of my recollection (which is frail) in the month of March 1780 but did not received my final discharge of until the following summer which was by me F with the Auditor of Public Accounts for the State of Virginia.

The Regiment I belonged to after taking up the line of march proceeded by the way of Fredericksburg Virginia to Dumfries in Maryland where the Regiment was inoculated from thence through Pennsylvania to New Jersey where the battle of Monmouth [June 28, 1778] was fought, your applicant being in that engagement, from thence to Middlebrook wer [where] the Army went into Winter quarters nothing material during the coming year wer [where] your applicant was, in the latter part of which I was sent amongst others into Virginia after some deserters from the main Army in the month of March when the Regiment was discharged. I hereby relinquish any claim – whatsoever to any pension or annuity except the present and declare that my name is not on the pension roll of any agency of any State.
