Pension application of John Maban (Mabin) S1686 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee, Dixon [sic, Dickson] County July Term 1833

On this 2nd day of July in the year 1833 personally appeared in open Court, before the Justices now sitting John Maben a resident of Dixon County & State of Tennessee aged Eighty four years who first being duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. He states that he was born in the County of Orange in the State of North Carolina in the year 1749 and his father moved from there to Guilford County where he entered the Service as well as he now recollects in the year 1776 under the Command of Colonel John Paistly [sic, John Paisley], Major John Donnell, Captain Archer Forbus [Arthur Forbis], Lieutenant William Wiley, Ensign William Gilmore from thence to Hillsboro in North Carolina as a guard Prisoners, we then were marched back to Guilford after a tour of three weeks. After this I was again called on to go against what was then called the Scotch, and we were marched to Fayetteville, and returned I was under the same officers as I have above stated. Lieutenant William Wylie who is now present will testify as to those two tours of duty this was about three weeks. He does not recollect the time we again went out on a tour against Fanning [David Fanning] the Tory General, under the Command of Captain Forbus in this trip we were about four weeks – we returned to Guilford, In the year 1781 I was again called on to go against Cornwallis under the Command of the same officers except Lieutenant William Wilie, who was not with me this trip. We marched into Macklenburg [sic, Mecklenburg County] – we were then compelled to retreat across the River Adkin [sic, Yadkin] where we took a stand in wait for the enemy, I was here taken sick and got a furlough to go home, and did so, I served in this tour of three months.

He states that he does not recollect what year for he is now old and infirm, but he has a distinct recollecting of entering the service as a volunteer in the horse under the Command of Captain Thomas Jenkins in the County of Guilford, we served in all as he firmly believes in actual service of eight months under the Command of Captain Jenkins, as a volunteer horseman, In them days they were called minute men and subject to be called at any moment, In all the service he rendered the government he states was Ten months and up. This is all that he can now recollect of his service, from Guilford County he moved to the County Dixon in the year 1807 where he now lives and has lived since the War. He has no evidence of his Service but the affidavit of William Wylie as part of his Service, and served as his Lieutenant and whose affidavit is attached nor has he any record of his age, his father's family Bible having been burnt by fire he hereby relinquishes any claim to a pension what ever except the present and declares that his name is not on the pension roll of the agency of any state in the union or Territory.
