Pension application of Martin Nease S1776 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Orange County SS

On this 1st day of September 1832, personally appeared in open Court, before the Court of Pleas & Quarter Sessions, of the County and State aforesaid, Martin Nease, of the said County & State, age seventy-one years last February, he supposes, who being first duly sworn according to law doth on his oath, make the following declaration, in order to obtain the benefit of the Act of Congress, passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

In the year 1799 [sic, 1779?], he was drafted, in the County of Orange & State of North Carolina, in the Militia of the State, for the term of nine months. He was in the company of Captain Young [Joseph Young], Lieutenant Patterson; -- Field officers General Butler [John Butler] & Col. Archibald Lytle. His company was organized near Haw River, & was marched to Savannah in the State of Georgia, by way of Salisbury & Camden. The British were in the neighborhood of Savannah during the time the declarant was there – no battle was fought – but there was some skirmishing. The declarant served out the nine months for which he was drafted, & was discharged on this side of Savannah –& returned home.

In December of the same year, he supposes, on the 28th he was again drafted in the County of Orange & State of North Carolina, for the term of three months, & was attached to the company of Captain Rogers [William Rogers] at first – and then was placed under the command of Captain O'Neal [William O'Neal] & Lieutenant Trousdale [James Trousdale]. From Orange, they were marched to Charleston, South Carolina; -- at Charleston, O'Neal was promoted, & Trousdale was appointed Captain of his company. This company belonged to General Lillington's [John Alexander Lillington's] Brigade. He was in no battle in this tour – was employed in making breastworks &c. He served out his term of three months, and was discharged at Charleston March 28, 1780 – as will appear by the printed discharge hereunto annexed – which appears not to have been signed. This declarant supposes that the signing was omitted in the hurry of business – but he is certain that he received the paper at the time, as a discharge. From Charleston he returned home. After the battle of Guilford [March 15, 1781], the declarant was again drafted in the County of Orange, for the term of three months – and drove a wagon from Orange County North Carolina to South Carolina, loaded with the baggage of Colonel Wooten & Colonel Farmer. When on his return with his wagon, within the limits of South Carolina, & being with the guard placed over the prisoners taken at the battle of the Eutaw [Eutaw Springs, September 8, 1781] – Colonel Malmedy [Francis de Malmedy, Marquis of Bretagnel placed the declarant in the charge of J. Galbraith D. Q. M.-- as will appear by the written discharge here unto annexed – and was discharged on the 18th September 1781 by J.

Galbraith, D. Q. M. When he was discharged by Galbraith, his term of three months service wanted a few days of being ended: he remembers that it was understood at the time Colonel Malmedy stopped him on his return with his wagon which was previously, of course, to the declarant's being left by the said Colonel with Galbraith – that declarant's term of service would expire by the time he could reach Hillsboro, N. C. with his wagon. The declarant returned home, & was not again in the service. He was born in North Hampton County in the State of Pennsylvania, he supposes somewhere about the year 1760. At the age of 13 years, or thereabouts, he was removed to the County of Orange & State of North Carolina, where he hath ever since resided. He has no record of his age. He is known to Major John Taylor, 1 John Efland, and John Ferrel, of his County & neighborhood. He has no other documentary evidence of his service than is herein set forth. He has procured the testimony, in the form of an affidavit of John Efland, of the County & State aforesaid as proof in part of his service. He hereby relinquishes every claim whatever to a pension or annuity, except the present, and declares that his name is not on the pension roll of the Agency of any State, so far as he has no knowledge

John Efland,² after being duly sworn according to law, before me, one of the Justices of the Peace for said County, maketh oath, that he served with Martin Nease, of the County & State aforesaid a tour of three months and the United States service, and the War of the Revolution, at Charleston South Carolina, and part, and that said Martin Nice was previously in the service at Savannah, Georgia.
