Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Virginia County of Southampton: SS

On this 19 day of November 1832 personally appeared in open Court before the Justices of the Court of Southampton now sitting William Oney a resident of Nottoway parish in the County of Southampton and State of Virginia aged seventy-one years and six months agreeable to the best information he can obtain from others born at or about the same time who have a register of their ages, he has none of his that he knows of, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832 –

That he entered the service of the State of Virginia under the following named Officers, and served as herein stated. He was enrolled in the militia in the County of Southampton in April 1777 a few days after he was seventeen years old and was drafted into the 2nd division, and was ordered into service at that time under Captain John Taylor Major Wills and Colonel Book Wills, and served a tower [tour] of duty of six weeks marching through Isle of Wight & Nansemond [counties], he then served a tower under Captain Myrick and Colonel Blunt in said Counties, he then served under Captain Samuel Kello and marched up James River and was in the Battle at Petersburg [April 25, 1781], under Majors Duval and Boyce and General Muhlenberg, after the battle at Petersburg he then listed in a light Infantry Company commanded by Captain wood heard Major Boyce and Colonel Dick, he was then in an engagement below Richmond at flowry hundred [perhaps, Flowerdew Hundred]², he was in another engagement at Sandy Point – and was discharged at Goochland Court House served three months – the next tower he was under Captain Whitehead Major Decloman [Christian Charles de Klauman] Major Boykin, Colonel Gaskins at Williamsburg when General Washington came there, he says he served other powers and under other Officers that he cannot recollect, nor can he say with any degree of certainty how long he served during the war, but served at different times from April 1777 until after the British Army surrendered at York Town (he thinks he must have served eighteen months or two years) he was discharged and returned to South Hampton where he has resided ever since. As to the different times when he entered the service, the length of the Towers of duty or many of the Officers names, the lapse of time and the effects of age it is impossible for him to recollect: – he never had a written discharge as it was not customary for the Militia in them days to receive them – that he resided in the County of Southampton and always entered

the service from that County, that he marched through the Counties of Isle of Wight, Nansemond, Norfolk, Surry, Prince George, and Rico, James City, York, Warwick and others that he does not recollect the names of – that he has no documentary evidence, but has the Testimony of two witnesses that were in the service with him – say Elias Love³ & Henry Love⁴

He hereby relinquishes every claim to a pension or annuity except the present, and declares that his name is not on the pension Roll of the agency of any State or territory.

This day personally appeared before us Benj. Griffin & George G. G. Gray two of the Justices of the peace for the County aforesaid Elias Love of the County aforesaid and being duly sworn deposeth and saith that they were with the said William Oney in service in the Revolutionary War at Petersburg when the battle was fought there, and at many other places and under a number of the officers as named in his declaration say Richmond, York and the old Gleek [?].

Personally appeared before me the undersigned a Justice of the peace for the County of Southampton William who being duly sworn deposeth & saith that by reason of age & the consequent loss of memory he cannot swear more positively as to the precise length of his service but according to the best of his recollection he served not less than 18 months and always as a private militia man and for such service I claim a pension.
