[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee, Marion County: Sct.

On this 22nd day of August 1832, personally appeared before the Justices of the Court of Pleas and quarter Sessions of said County James Jones a Resident of the County and State aforesaid, aged 77 years, who being first duly sworn according to law, doth on his oath, make the following Declaration, in order to obtain the benefit of the provision made by the act of Congress, passed June 7th 1832. That he enlisted, as a private, in the Army of the United States in the year 1776 or 77, with Peter Horry and was attached to Captain Snipes [William Clay Snipes'] Company, and served in the (no. of Regiment not recollected) Continental line under the following officers, to wit, Colonel Francis Marion, Major Peter Horry, Captain William Snipes, sergeants McDonnell, Jasper and Newton, and continued in said service until July 1782; -- That when he entered the service he lived in Cashaw [sic, Kershaw] District, in the State of South Carolina, that he was in the Battle fought at Savannah [Siege of Savannah] by General Lincoln [Benjamin Lincoln], at Wappoo Cut, by the same General at Bacon's Bridge by General Lincoln, at Camden (Gates defeat) [Battle of Camden, August 15-16, 1780]³ at Eutaw Springs [September 8, 1781], by General Greene [Nathanael Greene]; that he fought the British in each of said Engagements under said officers; that from the place of his Enlistment he was marched to Santee and there joined General Greene, at which place he left Greene and marched under Marion & Peter Horry to Waccamaw, where they stayed a while to recruit, from thence to Pee Dee in quest of Colonel Tynes [Lt. Col. Samuel Tynes], and then returned to Waccamaw, from there in quest of Colonel Tynes again, who they pursued to the State of North Carolina, then back to Camden in South Carolina, with De Kalb and Gates, and after the Battle of Camden, left the Main Army and ranged in different directions through South Carolina until the Battle of Eutaw Springs; from which place he ranged under General Marion, through South Carolina until the termination of the war (having enlisted during the war) when he was discharged by the officer with whom he enlisted for General Marion in the City of Charleston on the__ day of July 1782. That he herewith sends the probate of Barnett Cally [sic, Barnett Collyer] as the only proof of his services he can furnish, and that this is the first and only application for pension for Revolutionary services. He hereby relinquishes every claim whatever to a pension or annuity, except the present and he declares that his name is not on the pension Roll of any Agency in any

This day personally came before me Crockett McDonald a Justice of the peace in and for the County of aforesaid Barnett Collyer who being duly sworn deposes and saith that James Jones was a Regular soldier in the United States service in the revolutionary war and was regularly discharged by General Marion and said discharge was placed in his hand for keeping and that he has lost or so mislaid said discharge that it cannot be found by him the said Barnett Collyer.

S/ Barnett Collyer

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for service as a private for 2 years in the South Carolina militia.]
