Pension application of Aberhart Fetner S19294 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina, Richland District

On this 11th day of September in the year of our Lord 1846 personally appeared before me Samuel R. Black one of the magistrates of the District and State aforesaid Aberhart Fetner a resident of the District of Richland & State of South Carolina, aged Eighty-six on the 21st day of October next, who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the provision made by the Act of Congress passed the 7th June 1832. That he enlisted in the Army of the United States in the year 1777 in August of the same under Captain Derrill Hart in Colonel William Thomson's Regiment of foot as a musician and served in the same, the third Regiment, of the Continental line – that he continued in said Regiment until the Battle of Briar Creek [March 3, 1779] at which time he was taken prisoner and confined on board a Prison ship at Savannah in the State of Georgia – that he was afterwards retaken by Colonel Lee [Henry "Light Horse Harry" Lee] and served under Captain Rudolph [Michael Rudolph] in Colonel Lee's Regiment in which he served until the close of the War of the Revolution – that before entering the last mentioned Regiment he served under Captain Felix Warley who also belonged to Colonel William Thomson's Regiment of foot – that he is aged and in needy circumstances – He also answers to the following interrogatories upon oath. 1st Interrogatory: Where and in what year were you born[?] Answer: In Charleston on the 21st day of October 1760. 2nd Interrogatory Have you any Record of your age and if so where is it? Answer: Yes I have it now in my possession. 3rd Interrogatory: Where were you living when called into service; where have you lived since the Revolutionary War and where do you now live? Answer: At Granby in Lexington District South Carolina, afterwards in Chester District and now in Richland District adjoining Lexington District South Carolina. 4th Interrogatory: How were you called into service, were you drafted, did you volunteer or were you a Substitute, and if a Substitute, for whom? Answer: I enlisted in August 1777 under Captain Derrill Hart in Colonel William Thomson's Regiment afterwards under Captain Felix Warley in Colonel William Thomson's Regiment which was the third Continental Regiment in the Expedition to Florida. 5th Interrogatory: State the names of some of the Regular Officers who were with the Troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service. Answer: Col. William Thomson and Colonel Lee both of Continental Regiments. 6th Interrogatory: Did you ever receive a discharge and if so by whom was it given & what has become of it? Answer: I got a discharge from Colonel Lee but have since lost it. 7th Interrogatory: State the names of the persons to whom you are known in your

present neighborhood and who can testify as to your character for veracity and their belief of your service as a soldier of the Revolution. Answer: I am acquainted with Rev. John P. Cook and John C. Bell of Columbia. He also declares that he petitioned the Legislature of South Carolina in 1826 and was placed on the pension list of this State (see the accompanying copy by the Treasurer of the upper division) that those who were with then his witnesses are dead or gone without his reach. That he served in all five years and four months to wit from August 1777 to 25th of December 1782.

He hereby relinquishes every claim whatever to a pension except the same and declares that his name is not on the Pension Roll of any Agency in any State only on that of the State of South Carolina.

On this 29th day of September A.D. 1846 Personally appeared before me one of the Magistrates for the District of Richland in the State aforesaid Aberhart Fetner who upon his oath states that at the time he rendered service in the Army of the United States and during the Revolutionary War he was known and called by the name of John Aberhart Fetner, but some time after said war and at the instance & request of his Brother, he dropped the name "John" and was from that time to the present called "Aberhart Fetner."

Thompson for 2 or 3 years. p 14: Likewise William Taylor Senior² gave testimony that the veteran served as a

State of South Carolina Richland District: Personally appeared before me Benjamin Hart who upon oath states that he is Eighty one years of age and that he is well acquainted with Aberhardt Fetner who has made application to be placed on the pension list of the United States and that he knew him well when he enlisted under the brother of this Deponent Lieut. Derrill Hart in the Service of the United States in the 3rd Continental Regiment in the South Carolina line commanded by Col. William Thomson and that the said Aberhart Fetner is the identical man as above stated. This Deponent further states that he has heard his brother Lieut. Derrill Hart since say that the said Aberhart Fetner was a Fifer under his command.

The petition of Aberhart Fetner, respectfully Sheweth. – That your petitioner in the year 1777 enlisted as a musician in 3rd Regiment of State troops commanded by Colonel Thomson [William Thomson], – that he continued to Serve in Said Regiment until the battle of Briar Creek [March 3rd, 1779] at which time, he was taken prisoner, and confined on board a prison Ship at Savanna – Your Petitioner was afterwards retaken, and served under Colonel Rudulph in Colonel Lee's [Henry "Light Horse Harry" Lee's] Regiment until the Close of the Revolutionary War – Your Petitioner is now in the Sixty Seventh year of his age and in indigent Circumstances, – he has become unable by manual labor, to procure, a Subsistence, he therefore prays your Honorable body on account of his age and infirmities to be placed on the pension List
