Pension application of Joshua Ammons S21045 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." [p 7] State of South Carolina, Marlborough District} SS

Personally appeared Joshua Ammons of the State and District aforesaid Aged Seventy Six years the 22nd day of January last. Who being duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832.

That he enlisted in the Army of the year of One Thousand Seven Hundred and Seventyfive with Captain Samuel Wise a resident of this district, (then Craven County), and served in the Third Regiment of the South Carolina Militia under Colonel William Thompson [sic, William Thomson], Major Vandros [sic, probably a reference to Maj, John Vanderhorst], the other officer's names not now recollected. The terms of enlistment then six months certain or three years if required. With this reason, that at the expiration of six months service he might withdraw from the service by furnishing a substitute to continue on the three years, and after the six months were expired he substituted a man in his place, then after he substituted the man in his stead he marched in a Militia Company to Charleston, S. C. and it being found that there were more men there than was needed Captain Conner [Edward Conner] returned home with part of his men, but he with as many as were required continued in Charleston and served six weeks, under Capt, William Standard, then returned home. And that soon after he volunteered under Captain Henry William Harrington, in which company he served six months in Charleston and thereabouts, after which early in June 1777 he enlisted in said Third Regiment under Captain Uriah Goodwin, General Moultrie [William Moultrie], General of the Brigade, Charles Coats Worth Pinckney[sic, Charles Cotesworth Pinckney] Major General, and served two years and eleven months until Charleston was surrendered by General Lincoln [Benjamin Lincoln] to Lord Cornwallis, which was the 12th of May 1780, at which time he was taken prisoner. Then was kept a prisoner until the exchange took place, at or near Williamsburg in or about the first of August 1781. He was engaged in five battles and the first battle was at Savanna Town Georgia when the town was surrendered to the British by General Howe [Robert Howe]. Then marched through part of South Carolina to Stono Fort June 1779, to the best of his estimation which was the 2nd battle he was engaged in. The 3rd battle he was engaged in Savanna Town he thinks in October 1779. The 4th at the Siege of Charles Town when General Lincoln surrendered the town to Lord Cornwallis. The fifth, and last battle he was engaged in, was at York Town State of Virginia where he saw Lord Cornwallis deliver his sword to General Lincoln, said to be by direction of General Washington, in the same manner as General Lincoln delivered his to General Cornwallis at Charles Town. At which time he then said Ammons was present and saw the action. Then in a short time took a certificate from his Captain, Uriah Goodwin, that he had served his time he enlisted for, he returned to (now) Marlborough District, South Carolina. After

which he served four terms, each term one month. Then returned home to Marlborough District where he has resided ever since and further said that he has never received any compensation for his service. Neither was he ever on any pension roll in the United States. In the 3rd Regiment which deponent served in at first, he recollects the names of the following officers - Col Wm. Thompson, Major Vandross, Major Heron, Capt. John Carroway Smith [sic, John Carraway Smith¹], Capt. Joseph Warley, Captain Felix Warley, Captain Field Farrow [sic, Field Farrar²], Capt. John Donaldson, Capt. Brown, Capt. Hopkins [David Hopkins], Capt. Richard Jones, Lieut. Gascon [sic, probably a reference to Lieut. John Gaskins], Lieut. Wm. Tigrat [sic, probably William Taggard], Lieut. Dessaussure [sic, probably Lieut. Louis De Saussure³], Ensign Merry Mgyre [probably Merry McGuire⁴]. These names are spelled according to their sounds. Deponent recollects that these officers were in the United States Army at the Battle fought at Savanna Town when Gen Howe surrendered the town to the British. They were likewise at Stono Fort twelve or fifteen miles north of Charleston, S. C. when the battle was fought there between General Lincoln and Provost [Augustine Prevost]. They were also at Savannah when General Lincoln was repulsed at Savanna in attempting to storm the town then in possession of Prevost Major Wise. Captain Richard Jones, Lieut. Gascon⁵ he recollects were killed in that engagement. General Pulaski was killed at the same place. Those who were not killed at Savanna were in the army when Cornwallis took Charleston. The Deponent recollects the names of many other officers but supposes has named as many as are necessary. He has never received a discharge which was owing to this fact and others. Having been taken prisoner in Charleston, he was exchanged at or near Williamsburg in Virginia, there was no field officer present, and his Captain, Uriah Goodwin gave him a Certificate of that he had served out his time. This Certificate was taken to Philadelphia by a Wm. Vining to get Deponent's arrearage of wages due him by the Government for the last two years of his services and he has never seen the certificate since. He believes it is lost. He was born in Brunswick County Virginia between Roanoke and Meherrin Rivers, on the 22nd day of January 1756. His age was recorded in the family register which he has seen a great many years ago in the possession of an elder brother. He believes it to be lost at this time. He was living in Marlborough District South Carolina when he enlisted (each time). He has lived there ever since the Revolutionary War. He hereby relinquishes all claims to any other pension or annuity except the present - He also states that General Lafayette passed through Marlborough in 1830 and recognized him. He had seen Lafayette at Williamsburg, Virginia.

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for 2 years service as a private in the revolution.]




