[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## South Carolina, Greenville District

On this the tenth day of October 1832 personally appeared in open Court before the Judges of the Court of Common Pleas and General Sessions now sitting Shadrach Farmer a resident of Granville District State of South Carolina aged seventy-seven years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832.

That he entered the service of the United States under the following named officers and served as herein stated. He entered the service the first time in September just after the battle of Eutaw Springs [September 8, 1781], under Captain James Crawford and Colonel Fair [probably William Farr] he served three tours of three months each and one tour of a month – he left the service about the close of the War Lived in Union District South Carolina when he entered the Service – was drafted every time – was in no battles – He marched through the State of South Carolina, was at Orangeburg, at Ancrum's Ferry (now Columbia) – served his first tour at Ancrum's Ferry – under Colonel Fair and Captain Crawford – serve the second tour at Bacon's Bridge under Colonel Brannon [Thomas Brandon] and Lieutenant Blassingame Served the third tour at Orangeburg under Crawford and Fair – served one month at Brannon's block House [Brandon's Blockhouse?] under adjutant Montgomery and Lieutenant Woodson He served altogether 10 months – was never with any Continental Regiment – does not know any of the regular officers – He has no documentary evidence – he can procure the testimony of John Farmer as to one tour of three months at Ancrum's Ferry (now called Columbia S. C.) -- was born in Virginia – Halifax County in the year 55 – has no record of his age but has always heard his father say that he was born the day Braddock was defeated has lived since the Revolutionary War in South Carolina and now lives in Greenville never received a discharge – Jesse Rector, Mr Niny [?] and Mr. Green his neighbors can testify to his good character for truth and their belief in his service as a soldier of the Revolution. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State.

Personally came John Farmer<sup>1</sup> before me the subscriber Justice and being duly sworn makes oath that he knows of Shadrach Farmer serving 13 months tour at Ancram's Ferry in South Carolina (near Columbia) under Captain James Crawford and Colonel William Fair during the year that Cornwallis was taken at Yorktown that this deponent served with him in the same company and that he has good reason to believe that the said Shadrach Farmer – rendered other services during the revolutionary war and that he knows him to have been a true and faithful friend to his Country.
