[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of SC, Anderson District

On the Fourth day of March personally appeared in open Court before the Judge of the Court of Sessions and Common Pleas in the Said State and for the District aforesaid, now in Session, Joseph Griffin, residing in the State & District aforesaid, who being duly Sworn according to law, doth on oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup>, 1832: He entered the service of the United States in November 1780 as a volunteer private under Captain William Harris in Col. Joseph Haizes' [sic, Joseph Hayes'] Regiment of Militia and continued in service until January 1782 & was in service, with the exception of a short time when sick with the small pox in August 1781 though he was in camp when taken lodged in a house during his confinement and followed the troops as soon as able. Col. Hayes was killed at the Engagement at the Station bearing his name when Col. Levi Casey succeeded to the command of his Regiment. He subjoins the following as answers to the Interrogatories propounded by [the] War Department:

First: He was born in Virginia 9<sup>th</sup> August 1763.

Second: His age was recorded in a Family Bible by his Father which he transferred to one of his own but which is now destroyed.

Third: He was living in the adjoining District of Laurens when called into service and volunteered.

Fourth: He was in the Battle of Blackstocks [November 20, 1780] with Sumter [Thomas Sumter]; at the Battle of Cowpens [January 11, 1781] with Morgan [Daniel Morgan] and in the battle of Guilford [March 15, 1781] with Genl. Greene [Nathanael Greene].

Fifth: Never had any discharge in writing.

Sixth: He is known to Major William Milwee [William Mulwee] who lived near me during the war & has known me from boyhood. He thinks there are several persons yet alive in Laurens but cannot specify names as he intends going to that District to find out such persons as may be alive and still resident there.

The Deponent's name is not on the pension Roll of any agency of any state though he has been for some years in the receipt of a pension from the State of South Carolina which he will cheerfully relinquish for an allowance from the General Government. Personally appeared Robert Long<sup>3</sup> before me and being duly sworn on his oath saith that he was well acquainted with Joseph Griffin, a private in the Little River Regiment of Militia in the Revolutionary War that he served as a Refugee from the British and Tories under Colonel Joseph Hayes in the same Regiment with himself: he served under Captain William Haris [sic, Harris]; that he saw him in said Company in the first week of November in the year 1780, that he believes he was in the Battle at Blackstocks under General Sumter against Tarleton and at the defeat of Colonel More [sic, Moore] of the Tories under Colonel Washington and at the taking of the Fort of the Tories at Williams plantation by Colonel Hayes; and also at Tarleton's defeat at the Cowpens under General Morgan: and that he believes he served faithfully in American Service until the end of the Revolutionary War.

Personally appeared James Dillard<sup>4</sup> Esquire and old and Infirm person, before me Robert Long, one of the Justices of the Quorum of the District of Laurens aforesaid; and being duly sworn on his Oath saith that he was acquainted with Joseph Griffin a private Soldier in the Little River Regiment of South Carolina militia in the Revolutionary War under Colonel Joseph Hayes in Captain William Harris' Company he believes from about the 1<sup>st</sup> of November in the year 1780, that he was he believes in the defeat of Colonel Moore of the Tories on Bush River; and also at the taking Williams' Fort on the Little River; and also at Tarleton's Defeat by General Morgan at the Cowpens; and also at the Siege of Ninety-Six under General Greene; and that he has no doubt but that he served faithfully as a militia Soldier to the end of the Revolutionary war; the Colonel & Captain Harris both dead.

William Entriken<sup>5</sup> and Thomas Entriken<sup>6</sup> appeared personally before me and made oath that they were well acquainted with Joseph Griffin who applies for a pension during the War of the Revolution – as they all resided in the same neighborhood. He had the reputation of having been a faithful and active Whig soldier and neither of these Deponents ever heard the same in any manner questioned. Thomas Entriken saw him in the years 1780 and 1781 when in the Service and believes his statement of his service to be substantially true.



[p 47: Included among the papers filed under Joseph Griffin's name is a petition dated March 5, 1856, filed in Laurens District, SC, by Frances Susan Griffin in which she states that she is the minor daughter, aged 20 years, of Joseph Griffin, a revolutionary soldier, who received \$40 annually as a pension from the government. She seeks the bounty land she may be entitled to under the law. In this petition, she states that her father died on April 3, 1850 in Laurens District, SC.]

[p 50: Also attached is a document entitled "Claim of Minor Children for Bounty Land" dated December 20, 1881 in which Frances Susan Monroe, aged 46, as the child of Joseph Griffin. In this claim, she claims that her father served in 1776 & 1777 in the regiment commanded by Col. James Williams, in Laurens District, SC. She states that her father was in the Battles of Kings Mountain, Musgrove, Blackstocks, Hammonds [Hammond's Old Store], Cowpens, Guilford C. H., Long Cain, Ninety Six, Eutaw Springs &c and massacre at Hayes Station. She states that she was born September 28, 1835 in Anderson County, SC. She gives her mother's name as Nancy Black. In this claim, she states her father died near Martin's Depot (Laurens R. R. Station), in SC on the 3<sup>rd</sup> of Apr. 1850 and that he left no widow surviving him]

[Veteran was pensioned at the rate of \$40 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 12 months in the South Carolina militia.]
