[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina York District:

On this 27th day of March 1833 Personally appeared in open Court before his Honor Richard Gantt one of the Judges of the Court of Common Pleas and Sessions now sitting Andrew Kerr a resident of the State and District aforesaid aged seventy-seven years, who being first duly sworn according to law, doth, on his oath make the following declaration, in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated viz. that he was drafted in 1780 -- and entered the militia service of the State of South Carolina as a private soldier in a troop of Cavalry commanded by Captain McAffee¹ and Colonel Thomas Neel, was stationed at Philips Fort at the head of the Little River in the State of Georgia guarding the frontiers against the Indians -- remained in service four weeks besides the time consumed in going & returning from the above Fort, of this service he has no documentary evidence and cannot prove it by any witness now living except Captain James Martin².

He was again drafted the same year in the militia service of South Carolina under the command of Colonel Neel who was succeeded by Colonel Samuel Watson (Colonel Neel having returned home to recruit) Major William Bratton was also in command in the service as a private soldier he continued 3 ½ months partly at Orangeburg partly at Charleston and partly at Stono -- during this service applicant was in the engagement at Stono³ between the British commanded by Prevost [sic, Augustine Prevost] and the Americans commanded by General Lincoln. The Regiment in which applicant was discharged at Sheldon Bull's plantation 50 miles from Stono, he received no written discharge, of this service he has no documentary evidence and cannot now prove it otherwise than by the testimony of Captain James Martin hereto attached.

He was again drafted in 1781 and placed in militia company commanded by Captain John Henderson under the command of Colonel Moffet [sic, John Moffett], was stationed at Orangeburg the whole time as a reserve. General Green [sic, Nathanael Greene] Army being

between that point and Charleston, in this service as a private soldier continued 3 months and was discharged but received no written one, of this service he has no documentary evidence & cannot prove by any person now living except William Clasky [?]. He was in 1781 at the taking of Friday's Fort⁵ near Columbia South Carolina as a Waggoner under the command of Colonel Bratton, Colonel Lee [Henry "Light Horse Harry" Lee] of Virginia was at the taking of the Fort, in this service he volunteered and served as Waggoner [sic] one month and was discharged but received no written one of this service he has no documentary evidence nor can he prove it by any witness now living.

He again volunteered as a private soldier in a militia company commanded by Captain Jacob Barnett under the command of Colonel Lacey [Edward Lacey], they built a Fort near Williams Mill on Turkey Creek in this District and scoured the country on Little River in what is now called Mobley's settlement in Chester District South Carolina to keep down the Tories, cannot state the precise length of this service but was at least 3 weeks, he has no documentary evidence nor can he prove this service by any living witness nor can he State the year in which it was performed. After this he was on various occasions engaged as a private soldier in the service of his country for a few days at a time, on one of these he was one of a company of 18 volunteers under the nominal command of Captain Andrew Love who took 72 Tories commanded by Captain Stallions⁶ at the House of Stallions about 5 miles from Yorkville South Carolina this service he cannot now prove by any living witness.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

Where and in what year were you born?


Ans: I was born inMcLenburg [sic, Mecklenburg] County North Carolina in the year 1755.

Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Ans: I lived when called into service where I now do and have lived ever since viz. York

How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

Ans: I was drafted and volunteered as stated in my declaration.

State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

Ans: During my service at Stono Generals Henderson and Malmody [Francis de Malmedy, Marquis of Bretagne] I think Continental Officers of South Carolina and General Lincoln [Benjamin Lincoln] a regular Officer were with the troops Colonel Lee of Virginia was with the troops at Friday's Fort, names of regiments not recollected.

Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

Ans: I never did receive a written discharge.

State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Ans: Reverend George W. Davis, James B. Fulton and John Clark Sworn to & subscribed before me in open Court March 27 1833 S/A. McWhorter, CCCYC
