[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Greenville District: On this fifteenth day of October in the year while Lord 1833 personally appeared in open Court before the Judges of the Court of Common Pleas now sitting William Crane a resident of Greenville District State of South Carolina aged sixty-seven years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th, 1832.

That he entered the service of the United States under the following named officers and served as herein stated – He first volunteered for three months under Captain George Avery in the spring of 1782 – was stationed at Orangeburg in South Carolina under the command of Colonel William Fair [sic, William Farr] of the South Carolina Militia. He served the whole of this tour at Orangeburg. The second tour he volunteered again in the fall of the year 1782 for three months under the command of Lieutenant William Henly. This tour he served in an expedition against the Cherokee Indians under the command of Colonel William Fair. He was stationed some time near a place called the "Pine Log" – The troops under Colonel Fair met the Georgia troops in the Cherokee nation under the command of Colonel Clark [Elijah Clarke]. There was no regular engagement with the Indians but some skirmishes. He lived in Union District, South Carolina when he entered the service. He volunteered both tours. He was with no Continental regiments, or regular officers. He has no documentary evidence, and knows of no person except Jno Farmer [John Farmer] whose testimony he can procure as to his services – John Farmer, who now draws a pension, served with this applicant the tour in which he went against the Cherokee Indians, and will make affidavit to the fact. This applicant was born in Union District State of South Carolina in the year 1766. He has no record of his age but knows that he knew was sixteen years old when he first volunteered in 1782. Was living in Union District when called into service, and has lived in Spartanburg and Greenville Districts ever since the revolutionary War. He never received a written discharge. He is known in his present neighborhood to Robert Nelson, David Jackson, William King and others who can testify to his character for veracity and their belief of his services as a soldier of the revolution. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

To the Honorable the President and other members of the Senate the speaker and other members of the House of Representatives of the state of South Carolina the humble petition of William Crane Sheweth your Honorable body that in the year 1782 that he was called into service a two months tower [tour] of Duty as a South Carolina Militiaman under the command of Colonel William Fare [William Farr] against the Cherokee Indians that he obeyed the call and was Carried by his Commander aforesaid into the Nation that he served that tower of duty and as your petitioner is now old and infirm and also in indigent Circumstances your petitioner Begs that your honor [sic] body would take his Case under your Consideration and make him such Compensation as in your Great wisdom may think proper in your petitioner will ever pray November the 10th, 1831 S/ William Craine William Craine
