[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina, York District: SS

On this 16th day of October 1832 personally appeared in open court before Wm D. Martin Judge of the Court of Sessions and Common Pleas now sitting James Jamieson a resident of Chester District, State of South Carolina, aged in the Seventy Seventh year of who being first duly sworn according to law, doth make the following declaration in order to obtain the benefit of the act of Congress of the 7th June 1832.

That he entered the service of the United States as a volunteer in the year 1775 under Col. Neel [Thomas Neel] & General Richardson [Richard Richardson], against the Tories on Reedy River, commanded by Colonel Cunningham [Robert Cunningham or Patrick Cunningham], which body of Tories were taken prisoners, -- without any battle being fought. That in this tour he served according to the best of his knowledge three months.

He again volunteered in the month of June or July 1776 under Captain Thomas Kirkpatrick & Colonel Thomas Neel, on an expedition against the Cherokee tribe of Indians, and served under them six weeks.

He again volunteered under Captain Kirkpatrick in January 1779 and served two weeks against the Tories on Fairforest Creek in the State of South Carolina.

He volunteered again under Captain Thomas Kirkpatrick and Major Ross [Francis Ross] in an expedition to the State of Georgia, during this Campaign he was in the Battle of Briar Creek [March 3, 1779], where Colonel Ashe [John Ashe] was defeated by the British General Prevost [Augustine Prevost] -- Served in this tour three months.

After the Battle of Briar Creek before returning to South Carolina he again volunteered in an expedition under Col. Hammond against the Creek Indians Came on the Indians at the Oconee River, fought & defeated them. Served in this campaign two weeks.

He also served a two weeks tour at Wright's Bluff on the Santee River under Colonel William Bratton in the year 1780. Shortly after the fall of Charleston South Carolina while here he was appointed a Lieutenant.

A few days after his return he volunteered on a tour to North Carolina, under General Thomas Sumpter [sic, Thomas Sumter]. Before starting in this tour he was appointed and commissioned a Captain by Governor Rutledge [John Rutledge] of South Carolina, -- In this Campaign, He went on pursuit of the Tories in the Fork of the Yadkin River, -- immediately after fought & defeated the Tories at Ramsour's [Battle of Ramseur's Mill, June 20, 1780]² in North Carolina, -- After this Battle Returned & again joined General Sumter at Haggler's Branch,

Crossed the Catawba and defeated the British under Captain Hook [sic, Huck] at Williamson's [Battle of Williamson's Plantation or Huck's Defeat, July 12, 1790]³ -- Went to Rocky Mount [July 30, 1780]⁴ and attacked the British under Colonel Turnbull [George Turnbull] without Success. -- Crossed the River and one week after the Battle of Rocky Mount defeated the British & Tories at the Battle of the "Hanging Rock," [August 6, 1780]⁵ That in this Battle he was wounded by a musket shot through the body. -- After the Battle of the "Hanging Rock" he was carried to the Hospital at Charlotte in North Carolina. As soon as his wounds would permit he again joined his command, and carried on a partisan warfare until the Battle of Blackstocks [November 20, 1780]⁶ on the Tyger River about December 1780. --

Immediately after this he was taken prisoner by the Tories at his own house, and delivered up to Lord Cornwallis – With whom he was a prisoner for about one month, when he was paroled & set at Liberty, and not exchanged until after the capture of Cornwallis in October 1781 [October 19, 1781] – That from the time he Joined General Sumter in North Carolina to the time he was exchanged was about 17 months.

That during his Services he was not Stationed with any of the Continental troops. That according to the best of his knowledge he was born on Brandywine Creek in the State of Pennsylvania on the 10th day of March 1755. That he has no record of his age. That when he entered the Service of the United States he resided in the District of York State of South Carolina and that he now lives in Chester District in Said State. That he never Received any written Discharge from Service.

That he was commissioned a Captain by Governor Rutledge of South Carolina in 1780, and that he lost said Commission in Swimming a Creek on the night after he received his parole from Lord Cornwallis. --

He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State.

Personal examination of James Jamieson made in open Court before the Honorable Wm D. Martin a Judge of the Court of Sessions and Common pleas at York Court house October term 1832

1st Where and in what year were you born?

Answer: I was born on Brandywine Creek in the State of Pennsylvania, according to the best of my knowledge on the 10th March 1755

2nd Have you any record of your age and if so where is it?

Answer: I have no record of my age.

3rd Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Answer: When I entered the Service of the United States I lived in what is now in York District South Carolina. I lived in York District until about the year 1802. Since that time I have lived in Chester District in the same State and resides there at this time.

4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

Answer: I volunteered in the year 1775 under Colonel Neel & General Richardson as set forth in my declaration, and during all my Services in the revolution, I never served in any other [paper torn] as a volunteer.

5th State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

Answer: I never served where there were any Regular troops consequently knew no regular officers, -- As we carried on a partisan warfare against the Tories & British. I do not know the No. of the regiments in which I served or whether they were so numbered. My officers were Captain Kirkpatrick, Col. Neel, Colonel Bratton, General Thomas Sumter, and others referred to in my declaration to which I refer for the general circumstances of my service.

6th Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it? Did you ever Receive a Commission and if so, by whom was it signed and what has become of it?

Answer: I never did Received any written Discharge from Service.

Answer: I received a Lieutenant's Commission when at Wrights Bluff in the year 1780, signed by Governor Rutledge, this commission I cannot tell how I lost, a few days after my Return I received a Captain's commission signed by the same which I lost in Swimming a Creek the night after I received my parole, as a prisoner of Lord Cornwallis.

7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Answer: I would refer to all who know me but particularly to Henry Rea and Jacob

Black.

Personally appeared before me, the undersigned, a Justice of quorum for said District Captain James Jamieson who, being duly sworn deposeth and saith, that by reason of old age and consequent loss of memory, he cannot swear positively as to the precise length of his service – but according to the best of his recollection he served not less than the periods mentioned below and in the following grades; for 9 ½ months I served as a private, for two months I served as a Lieutenant For one year and five months I served as a Captain, and for such service I claim a pension.

In addition, the records indicate that payments were made to a James Jamieson as Lieutenant for 30 days; has Captain for 30 days, as Captain for 40 days, and as Captain for 21 days; and as Captain wounded at rocking him having served 40 days. In addition, payment was made to James Jamieson for service as a horseman for 62 days under Major Ross and Captain McCullok [sic]

Appeared John Jamieson son of Captain James Jamieson before me the Subscribing Magistrate and made oath in due form of law his [father] to wit Captain James Jamieson's death was recorded on the day of his burial by William Jamieson Esquire now deceased and remarked when he wrote it down this is what we ought to put on his headstone which record is hereunto appended which has been in possession of deponent ever since entered which was done as above stated before they started to the grave yard with the corpse of his Father Captain James Jamieson.


He Further says that there was no Physician or Clergyman in attendance and that his Funeral Close [clothes] was bought and made some one or two years before his death.

I James Kuykendall Clerk of the Court of General Sessions & Common Pleas for the District of York & State aforesaid, do hereby certify that satisfactory evidence has been exhibited at the office of the said Court to prove that Captain James Jamieson, a soldier of the Revolution, pensioner of the United States at the rate of \$383.31 per annum died at the house of his son, John Jamieson, on the 26th day of June 1838 in Chester District, South Carolina leaving three surviving children, to wit: William Jamieson Esquire, Mary Chambers, – and John Jamieson, all of lawful age, and that William Jamieson has since died leaving no children, and that Mary Chambers has not been heard of for the last three years, and that John Jamieson, the above named, is now the only child, known to be living.

In testimony whereof, I have hereunto affixed my seal of office & subscribed my name this 24th day of April 1847.

His pension was calculated on the basis of service for 2 months and 2 days as a Dragoon, for 30 days as a Lieutenant of Infantry, and for 4 months and 11 days as Captain of Dragoons. The veteran's pension was subsequently increased to \$338.31 per annum commencing March 4th, 1831.]

the petition of James Jamieson Late of York now of Chester District Humbly Sheweth

That your petitioner, then a Captain in Colonel Bratton's [William Bratton's] Regiment of militia received a wound in his right hip in the battle at hanging rock in Augt. 1780 which has occasioned him great pain & ever since with great difficulty he has supported himself & family by his labor without applying to his Country for assistance, but as he advances in years the Effects of his wound increases until he is no longer able to labor for his support.

Your petitioner therefore humbly prays that you will take his Case into Consideration and grant him such relief as in your wisdom shall seem meet. 13
