## Pension application of Joseph Morrow S21892 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of South Carolina, Chester District SS

On this 19<sup>th</sup> day of December 1832 Personally appeared in open Court before me Peter Wylie Judge of the Court of Ordinary of said District now Sitting Joseph Morrow a resident of the State & District aforesaid aged Seventy-two years who being first duly sworn according to law doth on his oath make the following Declaration, in order to obtain the benefit of the Act of Congress Passed June the 7<sup>th</sup> 1832, that he entered the Service of the United States under the following named officers and Served as herein stated Volunteered under Captain Philip Walker Lieutenant Alexander Campbell marched to 96 and took prisoners from there to Charleston cannot tell how long in service at this time Then Drafted for three months under Captain Philip Walker Lieutenant Alexander Campbell, marched to Black Swamp and joined General Lincoln's [Benjamin Lincoln's] Army Colonel Simmons and from thence passed Julifina Bridge where they skirmished with the British and from thence to Charleston the time drafted for three months but remained from the first of March until September say six months. Drafted again for three months under William Jones Captain Hugh McClure Lieutenant marched to go to Charleston met the Army on its retreat from Charleston after it had been captured by the British Served this time three or four weeks. The country became so over-run with the British and Tories so that all the Whigs were obliged to be in the Army for their own safety and the Safety of their country he then volunteered in Captain John McClure's Company John Steel Lieutenant Joined Sumter's [Thomas Sumter's] Army under Colonel Lacey [Edward Lacey] & Col. Winn continued with Sumter's Army in this State and North Carolina was at the defeat and entire Route of Captain Huck at Williamson's [July 12, 1780] where Huck was killed and many others continued with Sumter till they Battle of Hanging-Rock [August 6, 1780] where he had his arm shattered by a Ball by reason of which he had near lost his arm and still remains a cripple this wound put an end to his Services being peace made by the time his arm healed which was about two years which last tour lasted or he continued in the Army from May till August 3 or four months he further saith that he was at the skirmish at Mobley's Meeting house [May 1780] & the Battle at Rocky-Mount [July 30, 1780] these last places he says he forgot to put them in their places. Ans 3 I was living in State of South Carolina then in Craven County now Chester District when called into Service and has lived in the same place ever in & lives there now

Ans 4 I was sometimes volunteered & sometimes Drafted

Ans 5 I was with General Lincoln, General Sumter, Colonel Simmons [Maurice Simons?], Col. Lacey, Colonel Winn, Colonel Bratton [William Bratton], Col. Neel, the circumstances are set forth and the former part of the declaration

Ans 6 I never received a Discharge but dismissed

Ans 7 I am well acquainted with Colonel George Gill, John McCreary (a Late member of Congress), Captain John Douglas, John Rosborough, Clerk of the court, John McKee, James McCaw, James Harbison Captain – Rev'd Samuel McCreary, Rev'd John B. Davis

He hereby relinquishes every claim whatever to a pension or Annuity except the State pension he has received from the State of South Carolina on account of his wound. Sworn to & signed data above in open Court.

Personally appeared before me Peter Wylie Judge of the Court of Ordinary for said District Joseph Morrow who being duly sworn deposeth and saith that by reason of old age and the consequent loss of memory he cannot swear positively as to the precise length of his service but according to the best of his recollection he served not less in the first tour under Captain Philip Walker & took prisoners from 96 to Charleston then two months, next tour under Captain P. Walker when joined Lincoln's Army not less than six months next Tour under Captain William Jones when marched to go to Charleston when met the retreating Army, after the fall of Charleston not less than three weeks next or fourth Tour under Captain John McClure when he joined General Sumter's Army and with Col. Lacey & Col. Winn not less than three months before wounded and further saith that when he was wounded he retreated with the Army to North Carolina and by the time he quit the hospital it was at least 18 months & for such service I claim a pension & for period refer to history See Grimshaw<sup>5</sup> history United States page 159 &c. Sworn to & signed this 6<sup>th</sup> day of June 1833.

The Memorial of Joseph Morrow Sheweth that your memorialist who was a Soldier in the cause of his country the United States during the Revolutionary war and in that Cause Suffered much Fatigue and privations until the Battle of the Hanging-Rock where your Memorialist received a Severe wound in his right Arm which in a great degree Disabled that Arm his Country on that Account placed your Memorialist early on the pension list of South Carolina which

Your memorialist being old & infirm & having a support to make for himself & wife who is old and infirm Therefore hopes your Body will take his case under their consideration and grant him some Assistance by granting him Your Memorialist an Increase of pension & your memorialist As in duty bound will ever pray &c
