Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Spencer County: Sct.

On this 8th day of November 1832 personally appeared before the undersigned Justices of the peace, Jacob Heady of the County & State aforesaid aged eighty-two years & four months who being duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832.

That he resided in the State of North Carolina during the period of the Revolutionary war – that during the progress of the war, He served as a volunteer three months against the Cherokee Indians in the North Carolina Militia. He recollects that Colonel Christie [William Christian] commanded the Regiment & Captain Boyl Cobb the company in which he served, but cannot recollect the precise time, but thinks it was previous to the year 1780. He further states that he served 3 months also in the North Carolina Militia under General Greene. He believes in the year 1781 & was discharged from the service a few days previous to the Battle of Guildford [Guilford] – He recollects that Major Benjamin Herndon commanded the Battalion in which he served, but cannot recollect the names of the other officers. He further states that at another time he was called on to perform a tour also in the Militia of the State of North Carolina aforesaid (the precise time not recollected) but he hired a substitute who served in his place – He also performed several short tours of duty against the Tories (supposed in all about three months) previous to the Battle of Kings Mountain. He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any State.
